

HOUSE BILL No. 5832

March 7, 2006, Introduced by Reps. Gleason, Stakoe, Robertson, Zelenko, Hoogendyk,
Drolet and Clack and referred to the Committee on Local Government and Urban Policy.

A bill to amend 1909 PA 283, entitled

"An act to revise, consolidate, and add to the laws relating to the establishment, opening, discontinuing, vacating, closing, altering, improvement, maintenance, and use of the public highways and private roads; the condemnation of property and gravel therefor; the building, repairing and preservation of bridges; maintaining public access to waterways under certain conditions; setting and protecting shade trees, drainage, and cutting weeds and brush within this state; providing for the election or appointment and defining the powers, duties, and compensation of state, county, township, and district highway officials; and to prescribe penalties and provide remedies,"

by amending section 6 (MCL 224.6), as amended by 1982 PA 299.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 6. (1) ~~In any~~ **EXCEPT AS OTHERWISE PROVIDED BY LAW AND**
2 **UNDER SUBSECTION (4), (5), OR (6), IN A** county where the county road
3 system is adopted, a board of county road commissioners consisting
4 of 3 members shall be elected by the people of the county. —

1 **THE INITIAL ROAD** commissioners shall be appointed by the county
 2 board of commissioners or elected at a general or special election
 3 called for that purpose, as ~~shall be ordered~~ **DETERMINED** by the

5 (2) If the road commissioners are appointed, they shall hold
 6 office only until January 1 of the first odd numbered year

25 (4) **THE** election of county road commissioners shall not be
 26 mandatory in any county ~~which~~ **THAT** contains **ALL OR PART OF** 12
 27 surveyed townships ~~or more, either entire or fractional~~ as

5 (6) EXCEPT FOR A COUNTY WITH A POPULATION OF 1,000,000 OR MORE
6 OR AS OTHERWISE PROVIDED UNDER SUBSECTION (5), THE POWERS, DUTIES,
7 AND FUNCTIONS THAT ARE OTHERWISE PROVIDED BY LAW FOR A BOARD OF
8 COUNTY ROAD COMMISSIONERS MAY BE TRANSFERRED TO THE COUNTY BOARD OF
9 COMMISSIONERS BY A RESOLUTION AS ALLOWED UNDER SECTION 11 OF 1851
