- 2 SEC. 59. (1) THE DEFINITIONS IN SECTION 11 APPLY TO THIS
- 3 CHAPTER UNLESS OTHERWISE PROVIDED IN THIS CHAPTER.
- 4 (2) AS USED IN THIS CHAPTER:
- 5 (A) "HOUSEHOLD INCOME" MEANS THAT TERM AS DEFINED IN SECTION 6 508 OF THE INCOME TAX ACT OF 1967, 1967 PA 281, MCL 206.508.
  - (B) "LOW AND MODERATE INCOME" MEANS HOUSEHOLD INCOME OF LESS

- 15 (2) IF THE AUTHORITY DETERMINES THAT PROPERTY IS SUPPORTIVE
- 16 HOUSING PROPERTY AS DEFINED IN THIS CHAPTER, THE AUTHORITY SHALL
- 17 CERTIFY THAT PROPERTY AS SUPPORTIVE HOUSING PROPERTY.
- 18 (3) AN OWNER OF PROPERTY FOR WHICH CERTIFICATION AS SUPPORTIVE

- 20 PROPERTY CERTIFIED AS SUPPORTIVE HOUSING PROPERTY IS LOCATED MAY
- 21 APPEAL THE AUTHORITY'S DETERMINATION TO THE CIRCUIT COURT OF THE
- 22 COUNTY IN WHICH THE PROPERTY IS LOCATED.
- 23 SEC. 59B. THE AUTHORITY SHALL NOT CERTIFY MORE THAN 250
- 24 PARCELS OF PROPERTY AS SUPPORTIVE HOUSING PROPERTY IN EACH YEAR.
