## **HOUSE BILL No. 5946**

March 30, 2006, Introduced by Reps. Steil, Gosselin, Hoogendyk, Wenke, Vander Veen, Sheen, Stahl, Hansen, Booher, Nofs, Acciavatti and Pastor and referred to the Committee on Local Government and Urban Policy.

A bill to amend 1967 (Ex Sess) PA 8, entitled

"An act to provide for intergovernmental transfers of functions and responsibilities,"

by amending section 4 (MCL 124.534).

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 4. A contract shall include:
- 2 (a) A description of the functions or responsibilities to be
- 3 transferred.
- **4** (b) The effective date of the contract.
- 5 (c) The term of operation under the contract.
  - (d) The manner in which the affected employees, if any, of the participating political subdivisions shall be transferred,
  - reassigned, or otherwise treated. subject to the following:

(i) Such employees as are necessary for the operation thereof 1 2 shall be transferred to and appointed as employees subject to all rights and benefits. These employees shall be given seniority 3 4 credits and sick leave, vacation, insurance and pension credits in accordance with the records or labor agreements from the acquired 5 system. Members and beneficiaries of any pension or retirement 6 system or other benefits established by the acquired system shall 7 continue to have rights, privileges, benefits, obligations and 8 9 status with respect to such established system. The political subdivision to which the functions or responsibilities have been 10 11 transferred shall assume the obligations of any system acquired by 12 it with regard to wages, salaries, hours, working conditions, sick 13 leave, health and welfare and pension or retirement provisions for 14 employees. If the employees of an acquired system were not guaranteed sick leave, health and welfare and pension or retirement 15 pay based on seniority, the political subdivision shall not be 16 17 required to provide these benefits retroactively. 18 -(ii) No employee who is transferred to a position with the political subdivision shall by reason of such transfer be placed in 19 20 any worse position with respect to workmen's compensation, pension, seniority, wages, sick leave, vacation, health and welfare 21 insurance or any other benefits that he enjoyed as an employee of 22 23 such acquired system. (e) The manner in which any real property, facilities, 24 25 equipment, or other personal property required in the execution of the contract shall be transferred, sold, or otherwise disposed of 26 27 between the contracting parties.
