HOUSE BILL No. 5957

April 19, 2006, Introduced by Reps. Palsrok, Hildenbrand, Nofs and Clemente and referred to the Committee on Energy and Technology.

A bill to amend 1917 PA 350, entitled

"An act to regulate and license second hand dealers and junk dealers; and to prescribe penalties for the violation of the provisions of this act,"

by amending sections 1 and 3 (MCL 445.401 and 445.403).

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 1. (1) No A person, corporation, copartnership, or firm

- 11 PAYMENT SYSTEM, SO LONG AS THE PAYMENT IS NOT MADE IN CASH.
- 12 (F) IMMEDIATELY REMOVE THE PERSONAL PROPERTY OR OTHER VALUABLE
- 13 THING FROM THE WEBSITE AND NOTIFY THE LOCAL LAW ENFORCEMENT AGENCY
- 14 UPON LEARNING IF THE VERIFICATION REVEALS THAT THE PERSONAL
- 15 PROPERTY OR OTHER VALUABLE THING IS STOLEN.
- Sec. 3. Any AS USED IN THIS ACT:
- 17 (A) "SECOND HAND DEALER" OR "JUNK DEALER" MEANS ANY person,
