THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 281. (1) AN OFFICER OF A CORPORATION SHALL NOT DO ANY OF
- 2 THE FOLLOWING WITH THE INTENT TO DEFRAUD THE SHAREHOLDERS OF THAT
- 3 CORPORATION:
- 4 (A) AWARD, ATTEMPT TO AWARD, OR CONSPIRE WITH ANOTHER PERSON
- 5 TO AWARD COMPENSATION TO ANOTHER OFFICER OF THAT CORPORATION THAT
- 6 THE PERSON KNOWS OR HAS REASON TO KNOW IS EXCESSIVE.
- 7 (B) OBTAIN, ATTEMPT TO OBTAIN, OR CONSPIRE WITH ANOTHER PERSON
- 8 TO OBTAIN COMPENSATION THAT THE PERSON KNOWS OR HAS REASON TO KNOW
 - IS EXCESSIVE.

- 1 (C) PREPARE, ATTEMPT TO PREPARE, OR CONSPIRE WITH ANOTHER
