## **HOUSE BILL No. 6207**

June 15, 2006, Introduced by Rep. Gaffney and referred to the Committee on Health Policy.

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending sections 16903, 16905, and 16907 (MCL 333.16903, 333.16905, and 333.16907), as added by 1995 PA 126.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 16903. (1) An individual licensed under this part as a
- 2 marriage and family therapist shall use only the title "licensed
- 3 marriage and family therapist" or "licensed marriage counselor" or
- 4 the abbreviation "l.m.f.t." in representing his or her services in
- 5 the practice of marriage and family therapy to the public.
- 6 (2) Unless exempt under section 16905(3), only an individual
- 7 licensed under this part may advertise that he or she offers
- 8 marriage and family therapy; marriage or family counseling service

- 1 or advice; marriage or family guidance service or advice; marriage
- 2 or family relations service or advice; marriage or family problems
- 3 service or advice; marriage or family relations advice or
- 4 assistance; service in the alleviation of a marital or family
- 5 problem; or service of similar import or effect that is included in
- 6 the practice of marriage and family therapy.
- 7 (3) The board may grant a limited license to an individual who
- 8 has met the requirements of section 16909(a) and (b) in order to
- 9 permit that individual to obtain the experience required under
- 10 section 16909(c). The board shall not renew a limited license for
- 11 more than 6 years. A limited licensee shall do all of the
- 12 following:
- 13 (a) Use only the title "limited licensed marriage and family
- 14 therapist" or "limited licensed marriage counselor".
- 15 (b) Not represent that he or she is engaged in the independent
- 16 practice of marriage and family therapy.
- 17 (c) Practice only under the supervision of a fully licensed
- 18 marriage and family therapist.
- 19 (d) Confine his or her practice to an organized health care
- 20 setting or other arrangement approved by the board.
- 21 (4) An individual engaged in obtaining experience required
- 22 under section 16909(b) may use the title "marriage and family
- 23 therapist intern" or "marriage and family therapist trainee" during
- 24 the training period. The board shall not require an individual
- 25 obtaining experience required under section 16909(b) to hold a
- 26 limited license.
- 27 (5) THE FOLLOWING WORDS, TITLES, OR LETTERS OR A COMBINATION

- 1 THEREOF, WITH OR WITHOUT QUALIFYING WORDS OR PHRASES, ARE
- 2 RESTRICTED IN USE ONLY TO THOSE INDIVIDUALS AUTHORIZED UNDER THIS
- 3 PART TO USE THE TERMS AND IN A WAY PRESCRIBED BY THIS PART:
- 4 "MARRIAGE ADVISOR" OR "MARRIAGE CONSULTANT"; "FAMILY COUNSELOR",
- 5 "FAMILY ADVISOR", "FAMILY THERAPIST", OR "FAMILY CONSULTANT";
- 6 "FAMILY GUIDANCE COUNSELOR", "FAMILY GUIDANCE ADVISOR", OR "FAMILY
- 7 GUIDANCE CONSULTANT"; "MARRIAGE GUIDANCE COUNSELOR", "MARRIAGE
- 8 GUIDANCE ADVISOR", OR "MARRIAGE GUIDANCE CONSULTANT"; "FAMILY
- 9 RELATIONS COUNSELOR"; "MARRIAGE RELATIONS COUNSELOR", "MARRIAGE
- 10 RELATIONS ADVISOR", OR "MARRIAGE RELATIONS CONSULTANT"; OR "MARITAL
- 11 COUNSELOR" OR "MARITAL THERAPIST".
- 12 Sec. 16905. (1) This part does not apply to an individual
- 13 engaged in THE PRACTICE OF social work as defined in -section 1601
- 14 of the occupational code, Act No. 299 of the Public Acts of 1980,
- 15 being section 339.1601 of the Michigan Compiled Laws PART 185, in
- 16 the course of employment with a governmental agency or a reputable
- 17 social service agency regularly providing social work services as
- 18 an agency.
- 19 (2) This part does not apply to an ordained cleric or other
- 20 religious practitioner who is employed by or working under the
- 21 authority of an organization exempt from taxation under section
- 22 501(c)(3) of the internal revenue code of 1986, 26 U.S.C. USC
- 23 501, if the advice or counsel given by the cleric or other
- 24 religious practitioner is incidental to his or her duties as a
- 25 cleric or other religious practitioner, and if the cleric or other
- 26 religious practitioner does not hold himself or herself out to the
- 27 public as a marriage and family therapist licensed under this

- 1 article or use 1 or more of the titles listed in section
- $\frac{16263(1)(p)}{16903}$  and if no fee or donation is exacted for the
- 3 service.
- 4 (3) This part does not apply to a physician licensed under
- 5 this article who has completed an accredited psychiatric residency
- 6 program approved by the Michigan board of medicine or to a
- 7 psychologist fully licensed under this article, if both of the
- 8 following circumstances exist:
- 9 (a) The individual is practicing his or her profession in a
- 10 manner consistent with his or her education and training and is
- 11 practicing in a manner consistent with the code of ethics of that
- 12 profession.
- 13 (b) The individual does not hold himself or herself out to the
- 14 public as a marriage and family therapist licensed under this
- 15 article or use any of the titles listed in section  $\frac{-16263(1)(p)}{}$
- 16 16903 for advertising purposes. However, this subdivision does not
- 17 prohibit the individual from advertising under a telephone or other
- 18 business directory listing that uses those titles if the individual
- 19 discloses in the listing, in an unabbreviated fashion, the
- 20 profession in which he or she is licensed.
- 21 (4) This part does not limit an individual in, or prevent an
- 22 individual from, the practice of a statutorily regulated profession
- 23 or occupation if services to families, couples, or subsystems of
- 24 families are part of the services provided by that profession or
- 25 occupation, and if the individual does not hold himself or herself
- 26 out to the public as a marriage and family therapist licensed under
- 27 this article or use 1 or more of the titles listed in section

- 1  $\frac{16263(1)(p)}{16903}$ . As used in this subsection, "statutorily
- 2 regulated profession or occupation" means an occupation or
- 3 profession regulated by statute that includes, but is not limited
- 4 to, all of the following: a physician, attorney, social worker,
- 5 certified social worker, social work SERVICE technician, fully
- 6 licensed psychologist, limited licensed psychologist, temporary
- 7 limited licensed psychologist, licensed professional counselor,
- 8 limited licensed counselor, or school counselor.
- 9 Sec. 16907. (1) Subject to section 16913(2), the Michigan
- 10 board of marriage and family therapy is created in the department.
- 11 The board consists of the following 9 voting members who shall meet
- 12 the requirements of part 161: six licensed marriage and family
- 13 therapists and 3 public members.
- 14 (2) SUBJECT TO SECTION 16913(2), THE TERMS OF OFFICE OF
- 15 INDIVIDUAL MEMBERS OF THE BOARD CREATED UNDER SUBSECTION (1),
- 16 EXCEPT THOSE APPOINTED TO FILL VACANCIES, EXPIRE 4 YEARS AFTER
- 17 APPOINTMENT ON JUNE 30 OF THE YEAR IN WHICH THE TERM WILL EXPIRE.
- 18 Enacting section 1. This amendatory act does not take effect
- 19 unless Senate Bill No.\_\_\_\_ or House Bill No. 6147(request no.
- 20 05150'05) of the 93rd Legislature is enacted into law.
