- 5 is appointed, and for any additional time as determined by the

 - permit proper defense of all pending causes of action.
- 8 (2) ALL PROCEEDINGS IN ANY ADMINISTRATIVE TRIBUNAL, INCLUDING
 - WORKER'S COMPENSATION PROCEEDINGS, TO WHICH THE INSOLVENT INSURER
