- 2 maintained within this state, by all insurers authorized to

- 4 insurance, except the Michigan basic property insurance association
- 5 created pursuant to section 2920, an association of those insurers
- 6 to be known as the property and casualty guaranty association,
- 7 hereafter referred to as the "association". Each insurer shall be a
- 8 member of the association as a condition of its authority to
- 9 continue to transact insurance in this state.
