- 7 ANY OTHER SIMILAR SERVICE, AND ANY PROVIDER OF COMMUNICATIONS
- 8 SERVICES INVOLVING THE TRANSMISSION OF DATA OR ANY OTHER
- INFORMATION OR SIGNALS UTILIZING ANY MEDIUM OR METHOD, INCLUDING,

- 1 BUT NOT LIMITED TO, CABLE OR BROADBAND SERVICE, IP-ENABLED VOICE
- 2 SERVICE, CELLULAR OR MOBILE SERVICE, OR ANY OTHER SIMILAR SERVICE.
- 3 (B) "WAIVER OF CUSTOMER LIABILITY AGREEMENT" MEANS AN OPTIONAL
- 4 AGREEMENT BETWEEN A SERVICE PROVIDER AND A CUSTOMER OF THE SERVICE
- 5 PROVIDER UNDER WHICH THE SERVICE PROVIDER AGREES, IN RETURN FOR A
- 6 SPECIFIED CHARGE PAYABLE BY THE CUSTOMER TO THE SERVICE PROVIDER,
- 7 TO WAIVE ALL OR A PORTION OF THE CUSTOMER'S LIABILITY TO THE
- 8 SERVICE PROVIDER FOR INCURRED CHARGES DURING A DEFINED PERIOD IN
- 9 THE EVENT OF ANY OF THE FOLLOWING: THE CUSTOMER'S CALL TO ACTIVE
- 10 MILITARY SERVICE; INVOLUNTARY UNEMPLOYMENT; DEATH; DISABILITY;
- 11 HOSPITALIZATION; MARRIAGE; DIVORCE; EVACUATION; DISPLACEMENT DUE TO
