THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2682. (1) THE DEPARTMENT SHALL ESTABLISH A STATEWIDE
- 2 NETWORK OF CORD BLOOD STEM CELL BANKS THAT CONTAIN AT LEAST 150,000
- 3 UNITS OF HUMAN CORD BLOOD STEM CELLS. THE DIRECTOR OF THE
- 4 DEPARTMENT SHALL ENTER INTO CONTRACTS WITH QUALIFIED CORD BLOOD
- 5 STEM CELL BANKS TO ASSIST IN THE ESTABLISHMENT, PROVISION, AND
- MAINTENANCE OF THE NETWORK.
