## **HOUSE BILL No. 6317**

August 9, 2006, Introduced by Reps. Mortimer, Kahn, David Law, Nofs, Gaffney, Ball, Green, Vander Veen, Brandenburg, Garfield, Shaffer, Pastor, Newell, Angerer, Spade, McDowell, Gleason and Clack and referred to the Committee on Health Policy.

A bill to amend 1978 PA 368, entitled "Public health code,"

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:
