

# HOUSE BILL No. 6483

September 14, 2006, Introduced by Rep. Baxter and referred to the Committee on House Oversight, Elections, and Ethics.

A bill to amend 1954 PA 116, entitled  
"Michigan election law,"  
by amending section 848 (MCL 168.848), as added by 2003 PA 119.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

1           Sec. 848. (1) Each elected candidate subject to the Michigan  
2 campaign finance act, 1976 PA 388, MCL 169.201 to 169.282, and  
3 whose candidate committee received or expended more than \$1,000.00  
4 during the election cycle shall file a postelection statement with  
5 the ~~filing official designated to receive the elected candidate's~~  
6 ~~candidate committee campaign statements under section 36 of the~~  
7 ~~Michigan campaign finance act, 1976 PA 388, MCL 169.236~~ **SECRETARY**  
8 **OF STATE**. All of the following apply to a postelection statement

1 required by this section:

2 (a) The postelection statement ~~must~~ **SHALL** be on a form  
3 prescribed by the secretary of state.

4 (b) The elected candidate shall file the postelection  
5 statement before the elected candidate assumes office.

6 (c) The postelection statement shall include an attestation  
7 signed by the elected candidate that, as of the date of the  
8 postelection statement, all statements, reports, late filing fees,  
9 and fines required of the candidate or a candidate committee  
10 organized to support the candidate's election under the Michigan  
11 campaign finance act, 1976 PA 388, MCL 169.201 to 169.282, have  
12 been filed or paid.

13 (d) The postelection statement shall include an attestation  
14 signed by the elected candidate acknowledging that making a false  
15 statement in a postelection statement is punishable by a fine of  
16 not more than \$1,000.00 or imprisonment for not more than 5 years,  
17 or both.

18 (2) Failure to file a postelection statement as required by  
19 subsection (1) is a misdemeanor punishable by a fine of not more  
20 than \$500.00 or imprisonment for not more than 93 days, or both.

21 (3) Making a false statement in a postelection statement  
22 required under subsection (1) is perjury, punishable as provided in  
23 section 936.

24 Enacting section 1. This amendatory act takes effect January  
25 1, 2007.

26 Enacting section 2. This amendatory act does not take effect  
27 unless Senate Bill No. \_\_\_\_\_ or House Bill No. 6482(request no.

1 06777'06) of the 93rd Legislature is enacted into law.
