- 2 REPORT A CLINICAL TRIAL CONDUCTED OR SPONSORED TO THE DEPARTMENT AS
- 3 REQUIRED UNDER SECTION 9653 OR FAILS TO REPORT IN THE FORM
- 4 PRESCRIBED UNDER SECTION 9655 IS SUBJECT TO A CIVIL PENALTY AS
- 5 FOLLOWS:
- (A) FIRST VIOLATION -- A FINE OF NOT MORE THAN \$250,000.00.
 - (B) SECOND VIOLATION -- A FINE OF NOT MORE THAN \$500,000.00.
- 8 (C) THIRD AND SUBSEQUENT VIOLATIONS -- A FINE OF NOT MORE THAN
- 9 \$1,000,000.00.
