A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1290.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1290. (1) FOR THE 2005-2006 SCHOOL YEAR, IF A SCHOOL

- 4 50% OF THE PUPILS ACTUALLY ENROLLED IN THE SCHOOL BUILDING IN THE
- 5 IMMEDIATELY PRECEDING SCHOOL YEAR WERE ELIGIBLE FOR FREE LUNCH, THE
- 6 BOARD OF THE SCHOOL DISTRICT OR BOARD OF DIRECTORS OF THE PUBLIC
- 7 SCHOOL ACADEMY SHALL ENSURE THAT THE AVERAGE CLASS SIZE IN GRADES
- 8 K-3 IN THAT SCHOOL BUILDING IS NOT MORE THAN 17 PUPILS PER CLASS,
- WITH NOT MORE THAN 19 PUPILS IN ANY PARTICULAR CLASS.

- 22 PUPILS ACTUALLY ENROLLED IN THE SCHOOL BUILDING IN THE IMMEDIATELY
- 23 PRECEDING SCHOOL YEAR WERE ELIGIBLE FOR FREE LUNCH, THE BOARD OF
- 24 THE SCHOOL DISTRICT OR BOARD OF DIRECTORS OF THE PUBLIC SCHOOL
- 25 ACADEMY SHALL ENSURE THAT THE AVERAGE CLASS SIZE IN GRADES K-3 IN
- 26 THAT SCHOOL BUILDING IS NOT MORE THAN 17 PUPILS PER CLASS, WITH NOT
- 27 MORE THAN 19 PUPILS IN ANY PARTICULAR CLASS.

- 1 (5) BEGINNING IN THE 2009-2010 SCHOOL YEAR, AND FOR EACH
- 2 SCHOOL YEAR THEREAFTER, THE BOARD OF A SCHOOL DISTRICT OR BOARD OF
- 3 DIRECTORS OF A PUBLIC SCHOOL ACADEMY THAT OPERATES SOME OR ALL OF
- 4 GRADES K-3 SHALL ENSURE THAT THE AVERAGE CLASS SIZE IN GRADES K-3
