A bill to amend 1967 PA 281, entitled "Income tax act of 1967,"

(MCL 206.1 to 206.532) by adding section 437.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 437. (1) FOR THE 2005 TAX YEAR AND EACH TAX YEAR AFTER
- 2 THE 2005 TAX YEAR, AN INDIVIDUAL MAY DESIGNATE ON HIS OR HER ANNUAL
- 3 RETURN THAT A CONTRIBUTION OF \$2.00 OR MORE OF HIS OR HER REFUND BE
- 4 CREDITED TO THE PROSTATE CANCER RESEARCH FUND CREATED IN THE
- 5 PROSTATE CANCER RESEARCH FUND ACT. IF AN INDIVIDUAL'S REFUND IS NOT
- 6 SUFFICIENT TO MAKE A CONTRIBUTION UNDER THIS SECTION, THE
- 7 INDIVIDUAL MAY DESIGNATE A CONTRIBUTION AMOUNT AND THAT
- 8 CONTRIBUTION AMOUNT SHALL BE ADDED TO THE INDIVIDUAL'S TAX
- 9 LIABILITY FOR THE TAX YEAR.

- 4 (3) NOTWITHSTANDING ANY OTHER ALLOCATIONS OR DISBURSEMENTS

- 6 UNDER THIS SECTION IS IN EFFECT, AN AMOUNT EQUAL TO THE CUMULATIVE
