A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1163.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1163. (1) FOR THE 2008-2009 SCHOOL YEAR AND SUCCEEDING
- 2 SCHOOL YEARS AND SUBJECT TO SUBSECTION (3), THE DEPARTMENT SHALL
- 3 DEVELOP AND MAKE AVAILABLE TO SCHOOL DISTRICTS AND PUBLIC SCHOOL
- 4 ACADEMIES 1 OR MORE MODEL PROGRAMS MEETING THE REQUIREMENTS OF
- 5 SUBSECTION (2) THAT MAY BE ADOPTED AND IMPLEMENTED FOR THE PURPOSES
- OF SUBSECTION (2).
- (2) THE BOARD OF A SCHOOL DISTRICT OR LOCAL ACT SCHOOL
- DISTRICT OR BOARD OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY IS
- ENCOURAGED TO PROVIDE A COMPREHENSIVE CHARACTER DEVELOPMENT PROGRAM

- 20 (F) THE CHARACTER DEVELOPMENT PROGRAM SHOULD BE INCORPORATED,
- 21 AS MUCH AS POSSIBLE, INTO EACH SCHOOL'S REGULAR CURRICULUM AND
- 22 CLASSROOM INSTRUCTION.
- 23 (G) THE CHARACTER DEVELOPMENT PROGRAM SHOULD BE INTEGRATED
- 24 INTO EACH SCHOOL'S PROCEDURES AND ENVIRONMENT TO DEVELOP A SCHOOL
- 25 CLIMATE THAT PROMOTES POSITIVE CHARACTER TRAITS.
- 26 (3) THE DEPARTMENT'S OBLIGATION UNDER THIS SECTION IS LIMITED
- 27 TO THE AMOUNT OF FUNDS THE DEPARTMENT HAS AVAILABLE TO FULFILL ITS
