January 26, 2005, Introduced by Senators GARCIA, ALLEN, SWITALSKI, GOSCHKA, JELINEK and BISHOP and referred to the Committee on Education.

A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending section 1481 (MCL 380.1481), as added by 2000 PA 230.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 1481. (1) Not later than the beginning of the 2000-2001

 school year, the THE Michigan virtual university shall develop,

 implement, and operate the Michigan virtual high school, as

 described in this section.
 - (2) The Michigan virtual high school shall have the following goals:
 - (a) Significantly expand curricular offerings for high schools across this state through agreements with school districts or

- 1 licenses from other recognized providers.
- 2 (b) Create a statewide instructional model using interactive
- 3 multimedia tools delivered by electronic means, including, but not
- 4 limited to, the internet, digital broadcast, or satellite network,
- 5 for distributed learning at the high school level.
- 6 (c) Provide pupils with opportunities to develop skills and
- 7 competencies through on-line learning.
- 8 (d) Offer high school teachers opportunities to learn new
- 9 skills and strategies for developing and delivering instructional
- 10 services.
- 11 (e) Accelerate this state's ability to respond to current and
- 12 emerging educational demands.
- 13 (f) Grant high school diplomas through a dual enrollment
- 14 method with school districts.
- 15 (g) Act as a broker for college level equivalent courses, as
- 16 defined in section 1471, and dual enrollment courses from
- 17 postsecondary education institutions.
- 18 (3) The Michigan virtual high school course offerings shall
- 19 include, but are not limited to, all of the following:
- 20 (a) Information technology courses.
- 21 (b) College level equivalent courses, as defined in section
- **22** 1471.
- (c) Courses and dual enrollment opportunities.
- 24 (d) At-risk programs and services.
- 25 (e) General education development test preparation courses for
- 26 adjudicated youth.
- 27 (f) Special interest courses.

- 15 DIRECTORS OF A PUBLIC SCHOOL ACADEMY THAT OPERATES A HIGH SCHOOL
- 16 SHALL OFFER THE COURSE AS AN ELECTIVE FOR HIGH SCHOOL PUPILS AND
- 17 SHALL GRANT APPROPRIATE HIGH SCHOOL CREDIT FOR SUCCESSFUL
- 18 COMPLETION OF THE COURSE. THE COURSE SHALL INCLUDE COVERAGE OF AT
- 19 LEAST ALL OF THE FOLLOWING TOPICS:
- 20 (A) USE OF CONSUMER CREDIT.
- 21 (B) UNDERSTANDING MORTGAGES.
- 22 (C) HOW TO CLOSE A MORTGAGE OR OTHER CONSUMER FINANCIAL

- 24 (D) CREDIT SCORES AND THEIR EFFECT ON INDIVIDUALS.
- 25 (E) COSTS OF BORROWING MONEY.
- 26 (6) —(5)— Nonpublic school students and home-schooled
- 27 children may participate in course offerings of the Michigan
