A bill to amend 1994 PA 295, entitled

"Sex offenders registration act,"

by amending section 10 (MCL 28.730), as amended by 2004 PA 240.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 10. (1) Except as provided in this act, a registration or report is confidential and information from that registration or report shall not be open to inspection except for law enforcement purposes. The registration or report and all included materials and information are exempt from disclosure under section 13 of the freedom of information act, 1976 PA 442, MCL 15.243.
- (2) A department post, local law enforcement agency, or sheriff's department shall make information from the compilation

- 1 described in section 8(2) for the zip code areas located in whole
- 2 or in part within the post's, agency's, or sheriff's department's
- 3 jurisdiction available for public inspection during regular
- 4 business hours. A department post, local law enforcement agency, or

- 7 (3) The department may make information from the compilation

- 15 THAN 1 MILE FROM A ZIP CODE AREA DESIGNATED BY THE SUBSCRIBING
- 16 MEMBER OF THE PUBLIC.
- 17 (4) Except as provided in this act, an individual other than
- 18 the registrant who knows of a registration or report under this act
- 19 and who divulges, uses, or publishes nonpublic information
- 20 concerning the registration or report in violation of this act is
- 21 quilty of a misdemeanor punishable by imprisonment for not more
- than 93 days or a fine of not more than \$1,000.00, or both.
- 23 (5) An individual whose registration or report is revealed in
- 24 violation of this act has a civil cause of action against the
- 25 responsible party for treble damages.
- 26 (6) Subsections (4) and (5) do not apply to the compilation
- 27 described in section 8(2) or information from that compilation that
