SENATE BILL No. 129

February 1, 2005, Introduced by Senators SANBORN, BIRKHOLZ, GARCIA, PATTERSON, CROPSEY and GOSCHKA and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," (MCL 760.1 to 777.69) by adding section 2b to chapter XI.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 CHAPTER XI

SEC. 2B. (1) THE COURT MAY PLACE AN INDIVIDUAL CONVICTED OF A VIOLATION DESCRIBED IN SUBSECTION (4) ON PROBATION FOR ANY TERM OF YEARS BUT NOT LESS THAN 5 YEARS.

- (2) IF THE INDIVIDUAL IS PLACED ON PROBATION UNDER THIS SECTION, THE COURT MAY ORDER THE INDIVIDUAL, AS A CONDITION OF PROBATION, NOT TO ENGAGE IN ALL OF THE FOLLOWING CONDUCT:
 - (A) RESIDE IN HOUSING THAT IS LOCATED WITHIN 1 MILE OF A

- 10 (B) "SCHOOL PROPERTY" MEANS A BUILDING, PLAYING FIELD, OR
- 11 PROPERTY USED FOR SCHOOL PURPOSES TO IMPART INSTRUCTION TO CHILDREN
- 12 OR USED FOR FUNCTIONS AND EVENTS SPONSORED BY A SCHOOL, EXCEPT A
- 13 BUILDING USED PRIMARILY FOR ADULT EDUCATION OR COLLEGE EXTENSION
- 14 COURSES.
