SENATE BILL No. 161

February 3, 2005, Introduced by Senators ALLEN, BIRKHOLZ, STAMAS, VAN WOERKOM, JACOBS, JELINEK, BARCIA, GOSCHKA, GARCIA, GEORGE, CASSIS, TOY, GILBERT, JOHNSON, SANBORN, PATTERSON, BROWN, McMANUS, HARDIMAN, KUIPERS, BISHOP and BASHAM and referred to the Committee on Natural Resources and Environmental Affairs.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 82119 (MCL 324.82119), as added by 1995 PA 58.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 82119. A person shall not operate a snowmobile upon a public highway, land used as an airport or street, or on a public or private parking lot not specifically designated for the use of snowmobiles except under the following conditions and circumstances:

(a) A snowmobile may be operated on the right-of-way of a public highway, except a limited access highway, if it is operated at the extreme right of the open portion of the right-of-way and

- 2 be operated on the right-of-way of a public highway against the
- 3 flow of traffic if the right-of-way is a snowmobile trail
- 4 designated by the department in the plan developed pursuant to
- 5 section 82106(2) and is approved by the state transportation
- 6 department and the department. Snowmobiles operated on the right-
- 7 of-way of a public highway, as provided in this subdivision, shall
- 8 travel single file and shall not be operated abreast except when
- 9 overtaking and passing another snowmobile. In the absence of a
- 10 posted snowmobile speed limit, a snowmobile operated on the right-
- 11 of-way of a public highway, as provided in this subdivision, shall
- 12 be limited to the speed limit posted on the public highway.
- 13 (B) A SNOWMOBILE MAY BE OPERATED ON THE RIGHT-OF-WAY OF A
- 14 PUBLIC HIGHWAY THAT IS A LIMITED ACCESS HIGHWAY IF THE RIGHT-OF-WAY
- 15 IS A SNOWMOBILE TRAIL DESIGNATED BY THE DEPARTMENT IN THE PLAN
- 16 DEVELOPED PURSUANT TO SECTION 82106(2) AND IS APPROVED BY THE STATE
- 17 TRANSPORTATION DEPARTMENT AND THE DEPARTMENT. A SNOWMOBILE SHALL
- 18 ONLY BE OPERATED ON THAT RIGHT-OF-WAY IN THE MANNER PROVIDED IN
- 19 THAT PLAN AND WITHIN THE WIDTH OF THE DESIGNATED TRAIL.
- 20 (C) $\frac{-(b)}{}$ A snowmobile may be operated on the roadway or
- 21 shoulder when necessary to cross a bridge or culvert if the
- 22 snowmobile is brought to a complete stop before entering onto the
- 23 roadway or shoulder and the driver yields the right-of-way to an
- 24 approaching vehicle on the highway.
- 25 (D) -(c)— In a court action in this state where competent
- 26 evidence demonstrates that a vehicle that is permitted to be
- 27 operated on a highway pursuant to the Michigan vehicle code, Act

- 4 driver of the snowmobile involved in the collision shall be

- 6 (E) $\frac{-(d)}{}$ A snowmobile may be operated across a public
- 7 highway other than a limited access highway, at right angles to the
- 8 highway, for the purpose of getting from 1 area to another when the
- 9 operation can be done in safety and another vehicle is not crossing
- 10 the highway at the same time in the same general area. An operator
- 11 shall bring his or her snowmobile to a complete stop before
- 12 proceeding across the public highway and shall yield the right-of-
- 13 way to all oncoming traffic.
- 14 (F) -(e) Snowmobiles may be operated on a highway in a
- 15 county road system that is not normally snowplowed for vehicular
- 16 traffic and on the plowed right-of-way or shoulder when no right-
- 17 of-way exists on a snowplowed highway in the county road system,
- 18 outside the corporate limits of a city or village, that is
- 19 designated and marked for snowmobile use by the county road
- 20 commission having jurisdiction. Upon the request of a county road
- 21 commission that has designated all county roads outside the
- 22 corporate limits of a city or village for snowmobile use, the state
- 23 transportation department shall erect at county road commission
- 24 expense and shall maintain, in accordance with the Michigan manual
- 25 of uniform traffic control devices standards, the basic snowmobile
- 26 sign unit together with a supplemental panel stating "permitted on
- 27 right-of-way or shoulder of all (county name) roads --

- 2 state trunk line highways and county roads. A SIGN ERECTED BEFORE

- 5 (G) -(f) A -duly constituted law enforcement officer of a
- 6 local unit of government or the state may authorize use of a
- 7 snowmobile on a public highway or street within his or her
- 8 jurisdiction when an emergency occurs and conventional motor
- 9 vehicles cannot be used for transportation due to snow or other
- 10 extreme highway conditions.
- 11 (H) -(g) A snowmobile may be operated on a highway or street
- 12 for a special event of limited duration conducted according to a
- 13 prearranged schedule only under permit from the governmental unit
- 14 having jurisdiction. The event may be conducted on the frozen
- 15 surface of public waters only under permit from the department.
- 16 (I) $\frac{h}{h}$ A city or village by ordinance may designate 1 or
- 17 more specific public highways or streets within its jurisdiction as
- 18 egress and ingress routes for the use of snowmobiles. A city or
- 19 village acting under the authority of this subdivision shall erect
- 20 and maintain, in accordance with the Michigan manual of uniform
- 21 traffic control devices standards, a sign unit giving proper notice
- 22 of the designation.
