A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 40111b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 40111B. (1) A PERSON SHALL NOT DO ANY OF THE FOLLOWING:
- 2 (A) ENGAGE IN COMPUTER-ASSISTED REMOTE HUNTING.
- 3 (B) PROVIDE OR OPERATE, WITH OR WITHOUT REMUNERATION,
- 4 FACILITIES FOR COMPUTER-ASSISTED REMOTE HUNTING.
 - (C) PROVIDE OR OFFER TO PROVIDE, WITH OR WITHOUT REMUNERATION,
- 6 EQUIPMENT SPECIALLY ADAPTED FOR COMPUTER-ASSISTED REMOTE HUNTING.
- 7 THIS SUBDIVISION DOES NOT PROHIBIT PROVIDING OR OFFERING TO PROVIDE
- 8 ANY OF THE FOLLOWING:
 - (i) GENERAL-PURPOSE EQUIPMENT, INCLUDING A COMPUTER, A CAMERA,

- 1 FENCING, BUILDING MATERIALS, OR A FIREARM, BOW, OR CROSSBOW.
- 2 (ii) GENERAL-PURPOSE COMPUTER SOFTWARE, INCLUDING AN OPERATING
- 3 SYSTEM AND COMMUNICATIONS PROGRAMS.
- 4 (iii) GENERAL TELECOMMUNICATIONS HARDWARE OR NETWORKING SERVICES
- 5 FOR COMPUTERS, INCLUDING ADAPTERS, MODEMS, SERVERS, ROUTERS, AND
- 6 OTHER FACILITIES ASSOCIATED WITH INTERNET ACCESS.
- 7 (2) AS USED IN THIS SECTION:
- 8 (A) "COMPUTER-ASSISTED REMOTE HUNTING" MEANS THE USE OF A
- 9 COMPUTER OR ANY OTHER DEVICE, EQUIPMENT, OR SOFTWARE TO REMOTELY
- 10 CONTROL THE AIMING AND DISCHARGE OF A FIREARM, BOW, OR CROSSBOW TO
- 11 TAKE GAME LOCATED IN THIS STATE.
- 12 (B) "FACILITIES FOR COMPUTER-ASSISTED REMOTE HUNTING" INCLUDES
- 13 REAL PROPERTY AND IMPROVEMENTS ON THE PROPERTY ASSOCIATED WITH
- 14 HUNTING, SUCH AS HUNTING BLINDS, OFFICES, AND ROOMS EQUIPPED TO
- 15 FACILITATE COMPUTER-ASSISTED REMOTE HUNTING.
