A bill to amend 1978 PA 368, entitled "Public health code,"

(MCL 333.1101 to 333.25211) by adding section 17766b.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 17766B. (1) EXCEPT AS OTHERWISE PROVIDED UNDER THIS
- 2 SECTION, A PERSON WHO POSSESSES EPHEDRINE OR PSEUDOEPHEDRINE FOR
- 3 RETAIL SALE PURSUANT TO A LICENSE ISSUED UNDER THE GENERAL SALES
- 4 TAX ACT, 1933 PA 167, MCL 205.51 TO 205.78, SHALL DO EACH OF THE
- 5 FOLLOWING:
- (A) MAINTAIN ALL PRODUCTS THAT CONTAIN ANY COMPOUND, MIXTURE,
 - OR PREPARATION CONTAINING ANY DETECTABLE QUANTITY OF EPHEDRINE OR
 - PSEUDOEPHEDRINE, A SALT OR OPTICAL ISOMER OF EPHEDRINE OR

- 1 PSEUDOEPHEDRINE, OR A SALT OF AN OPTICAL ISOMER OF EPHEDRINE OR
- 2 PSEUDOEPHEDRINE BEHIND A COUNTER WHERE THE PUBLIC IS NOT PERMITTED
- 3 EVEN IF THE PRODUCT MAY BE LAWFULLY SOLD OVER THE COUNTER WITHOUT A
- 4 PRESCRIPTION UNDER FEDERAL LAW.
- 5 (B) REQUIRE THE PURCHASER OF A PRODUCT DESCRIBED UNDER
- 6 SUBDIVISION (A) TO PRODUCE A VALID PHOTO IDENTIFICATION THAT

- 12 TO CHILDREN UNDER 12 YEARS OF AGE ACCORDING TO LABEL INSTRUCTIONS.
- 13 (B) A PRODUCT THAT THE STATE BOARD OF PHARMACY, UPON
- 14 APPLICATION OF A MANUFACTURER, EXEMPTS FROM THIS SECTION BECAUSE
- 15 THE PRODUCT HAS BEEN FORMULATED IN SUCH A WAY AS TO EFFECTIVELY
- 16 PREVENT THE CONVERSION OF THE ACTIVE INGREDIENT INTO
- 17 METHAMPHETAMINE.
- 18 (3) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A
- 19 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 2 YEARS OR
- 20 A FINE OF NOT MORE THAN \$2,000.00, OR BOTH.
- 21 (4) A PERSON WHO FURNISHES FRAUDULENT IDENTIFICATION TO
- 22 PURCHASE A PRODUCT DESCRIBED UNDER SUBSECTION (1) (A) IS GUILTY OF A
- 23 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 2 YEARS OR
- 24 A FINE OF NOT MORE THAN \$2,000.00, OR BOTH.
