## **SENATE BILL No. 450**

May 3, 2005, Introduced by Senators JACOBS, THOMAS and LELAND and referred to the Committee on Economic Development, Small Business and Regulatory Reform.

A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998," by amending sections 1111 and 1113 (MCL 436.2111 and 436.2113), section 1113 as amended by 2004 PA 134, and by adding section 1116; and to repeal acts and parts of acts.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 1111. (1) The sale of beer and wine between the hours of 2 a.m. and 12 midnight 7 A.M. on Sunday may be prohibited in any county, city, village, or township by a majority vote of the electors voting at a regular state election. Not more often than once in every 4 years, upon the filing of a petition with the county, city, village, or township clerk, as applicable, requesting the submission of the question of the Sunday sale of beer and wine,

- 1 the clerk shall submit that question to the electors of the county,
- 2 city, village, or township at the next regular state election held
- 3 in that county, city, village, or township. A petition filed under
- 4 this subsection shall be filed not less than 60 days before the
- 5 regular state election. A ballot question under this subsection
- 6 shall not be submitted more often than once in any 4-year period.
- 7 (2) In the case of a county, city, or township, the petition
- 8 shall be signed by a number of the registered and qualified
- 9 electors of the county, city, or township that is not less than 35%

- 25 (4) All votes on the question submitted to the electors under
- 26 this section shall be taken, counted, and canvassed in the same
- 27 manner as votes cast in county, city, village, or township

- 1 election, as applicable, are taken, counted, and canvassed. Ballots
- 2 shall be furnished by the election commission or similar body of
- 3 the respective county, city, village, or township. If a majority of
- 4 the electors voting at an election conducted under this section
- 5 vote in favor of the question submitted, the sale of beer and wine
- 6 within that county, city, village, or township between the hours of
- 7 2 a.m. and -12 midnight 7 A.M. on Sunday is prohibited.
- 8 Sec. 1113. (1) Except as provided in subsection (2), (3), or
- 9 (5), a licensee enumerated under section 525 or any other person
- 10 shall not sell at retail, give away, or furnish, and a person shall
- 11 not knowingly and willfully buy, spirits or mixed spirit drink
- 12 between the hours of 2 a.m. and -12 midnight 7 A.M. on Sunday. If
- 13 January 1 falls on Sunday, the hours may be extended to 4 a.m.
- 14 (2) If the legislative body of a county has authorized the
- 15 sale of spirits and mixed spirit drink for consumption on the
- 16 premises on Sunday, by resolution approved by a majority of the
- 17 legislative body voting on that resolution, the spirits and mixed
- 18 spirit drink may be sold after -12 noon 7 A.M., EST, in an
- 19 establishment licensed under this act in which the gross receipts
- 20 derived from the sale of food and other goods and services exceed
- 21 50% of the total gross receipts. With respect to an action taken by
- 22 the legislative body or if the legislative body fails to act, a
- 23 petition may be filed with the county clerk requesting the
- 24 submission of the question of the sale of spirits and mixed spirit
- 25 drink for consumption on the premises in addition to beer and wine
- 26 on Sunday. The petition shall be signed by a number of the
- 27 registered and qualified electors of the county that is not less

- 1 than 8% of the total number of votes cast for all candidates for
- 2 the office of secretary of state in the county at the last general
- 3 election held for that purpose. The question shall not be submitted
- 4 to the electors of a county more than once every 4 years. The
- 5 county clerk shall submit the question at the next regular state
- 6 election held in the county if the petitions are filed not less
- 7 than 60 days before the election. The question of the sale of
- 8 spirits and mixed spirit drink for consumption on the premises, in
- 9 addition to beer and wine, on Sunday shall be submitted by ballot
- 10 in substantially the following form:
- "Shall the sale of spirits and mixed spirit drink for
- 12 consumption on the premises be permitted on Sunday in an
- 13 establishment licensed under the Michigan liquor control code of
- 14 1998 in which the gross receipts derived from the sale of food or
- 15 other goods and services exceed 50% of the total gross receipts
- 16 within the county of ..... under the provisions of the law
- 17 governing the sale of spirits and mixed spirit drink for
- 18 consumption?

- 20 No .....".
- 21 (3) If the legislative body of a county has authorized the
- 22 sale of spirits and mixed spirit drink for consumption off the
- 23 premises on Sunday by resolution approved by a majority of the
- 24 legislative body voting on the resolution, spirits and mixed spirit
- 25 drink may be sold after -12 noon- 7 A.M., EST, in a retail
- 26 establishment licensed under this act. With respect to an action
- 27 taken by the legislative body or if the legislative body fails to

- 1 act, a petition may be filed with the county clerk requesting the
- 2 submission of the question of the sale of spirits and mixed spirit
- 3 drink for consumption off the premises, in addition to beer and
- 4 wine, in a retail establishment licensed under this act on Sunday.

- 6 qualified electors of the county that is not less than 8% of the
- 7 total number of votes cast for all candidates for the office of

- 1 county elections are taken, counted, and canvassed. A ballot shall
- 2 be furnished by the election commission or similar body of the
- 3 county. If a majority of the electors voting at an election vote in
- 4 favor of the proposal, spirits and mixed spirit drink may be sold
- 5 in the county under this act for consumption on the premises or by
- 6 a retail establishment for consumption off the premises, in
- 7 addition to beer and wine, on Sunday. The sale shall not be
- 8 permitted in a city, village, or township in which the sale of
- 9 spirits and mixed spirit drink is prohibited under this act. A
- 10 violation of this section is a misdemeanor. This section does not
- 11 apply to spirits and mixed spirit drink served to a bona fide guest
- 12 in the residence of a person or sold or furnished for medicinal
- 13 purposes as provided for in this act.
- 14 (5) A licensee enumerated under section 525 or any other
- 15 person shall not sell at retail, and a person shall not knowingly
- 16 and willfully buy, alcoholic liquor between the hours of 9 p.m. on
- 17 December 24 and 7 a.m. on December 26. If December 26 falls on
- 18 Sunday, the hours of closing shall be determined pursuant to this
- 19 act. The legislative body of a city, village, or township, by
- 20 resolution or ordinance, may prohibit the sale of alcoholic liquor
- 21 on Sunday or a legal holiday, primary election day, general
- 22 election day, or municipal election day.
- 23 SEC. 1116. (1) NOTWITHSTANDING R 436.1403 OF THE MICHIGAN
- 24 ADMINISTRATIVE CODE AND EXCEPT AS OTHERWISE PROVIDED BY THIS ACT
- 25 AND RULE OF THE COMMISSION, A LICENSEE SHALL NOT SELL, GIVE AWAY,
- 26 OR FURNISH ALCOHOLIC LIQUOR BETWEEN THE HOURS OF 2 A.M. AND 7 A.M.
- 27 ON ANY DAY.

- 1 (2) SUBSECTION (1) DOES NOT PREVENT ANY LOCAL GOVERNMENTAL
- 2 UNIT FROM PROHIBITING THE SALE OF BEER AND WINE ON SUNDAYS UNDER
- 3 SECTION 1111 AND DOES NOT PREVENT ANY LOCAL GOVERNMENTAL UNIT FROM
- 4 PROHIBITING THE SALE OF SPIRITS AND MIXED SPIRIT DRINK ON SUNDAYS
- 5 UNDER SECTION 1113.
- 6 Enacting section 1. Section 1114 of the Michigan liquor
- 7 control code of 1998, 1998 PA 58, MCL 436.2114, is repealed.
