A bill to amend 1976 PA 451, entitled "The revised school code,"

by amending sections 4 and 5 (MCL 380.4 and 380.5), as amended by 2003 PA 299.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- Sec. 4. (1) "Educational media center" means a program

 operated by an intermediate school district and approved by the

 state board that provides services to local school districts or

 constituent districts under section 671.
 - (2) "Handicapped person" shall be defined by rules promulgated by the state board. Handicaps include, but are not limited to, mental, physical, emotional, behavioral, sensory, and speech handicaps.
 - (3) "Intermediate school board" means the board of an
