May 31, 2005, Introduced by Senator JOHNSON and referred to the Committee on Appropriations.

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"

- 1 commercial lookup request only if the request is in a form or
- 2 format prescribed by the secretary of state. The secretary of

- 5 SUBSECTION SHALL BE CREDITED TO THE TRANSPORTATION ADMINISTRATION

- 8 (3) In order to provide an individual, historical snowmobiling
- 9 record, the secretary of state shall create and maintain a
- 10 computerized central file that includes the information contained
- 11 on application forms received under this part and the name of each
- 12 person who is convicted of an offense, who fails to comply with an
- 13 order or judgment issued, or against whom an order is entered under
- 14 this part or former 1968 PA 74. The computerized central file shall
- 15 be interfaced with the law enforcement information network as
- 16 provided in the L.E.I.N. policy council act of 1974, 1974 PA 163,
- 17 MCL 28.211 to 28.216.
- 18 (4) The secretary of state shall not provide an entire
- 19 computerized central or other file of records maintained under this
- 20 part to a nongovernmental person or entity, unless the purchaser
- 21 pays the prescribed fee or price for each individual record
- 22 contained within the computerized file.
- 23 (5) A certified copy of an order, record, or paper maintained
- 24 in this record is admissible in evidence in like manner as the
- 25 original and is prima facie proof of the facts stated in the
- 26 original.

- 2 Enacting section 2. This amendatory act does not take effect
