- 6 (C) FAILS TO APPROPRIATELY USE OR ISSUE PAYMENT FROM A
- 7 CUSTODIAL FUND.
- 8 (D) IS INVOLVED IN CAPPING, SHILLING, OR STEERING RELATIVE
- 9 TO AN AUCTION.
- 10 (E) FAILS TO DISCLOSE HIS OR HER REGISTRATION NUMBER ON ALL
- 11 ADVERTISING.
- 12 (F) KNOWINGLY MISREPRESENTS THE NATURE OR VALUE OF AN ITEM
- 13 BEING AUCTIONED.
- 14 (G) VIOLATES THE REQUIREMENTS OF THIS ARTICLE OR A RULE
- 15 PROMULGATED UNDER THIS ARTICLE.
