THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 11514. (1) The legislature declares that optimizing

- 4 plan. and further that recycling RECYCLING and reuse of materials

- 19 (a) Used oil as defined in section 16701.
- 20 (b) A lead acid battery as defined in section 17101.
- 21 (c) Low-level radioactive waste as defined in section 2 of the
- 22 low-level radioactive waste authority act, 1987 PA 204, MCL
- **23** 333.26202.
- 24 (d) Regulated hazardous waste as defined in R 299.4104 of the
- 25 Michigan administrative code.
- 26 (e) Liquid waste as prohibited by R 299.4432(2)(c) of the
- 27 Michigan administrative code. BULK OR NONCONTAINERIZED LIQUID
