SENATE BILL No. 782

September 29, 2005, Introduced by Senators VAN WOERKOM and BARCIA and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 66.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 66. (1) IF A PERSON HAS CUSTODY OF A DOG OR WOLF-DOG
- 2 CROSS AND THE PERSON KNOWS OR HAS REASON TO KNOW THAT THE DOG OR
- 3 WOLF-DOG CROSS HAS BITTEN ANY INDIVIDUAL, THE PERSON SHALL
- 4 IMMEDIATELY DO BOTH OF THE FOLLOWING:
 - (A) PROVIDE THE INDIVIDUAL WHO WAS BITTEN WITH ALL OF THE FOLLOWING INFORMATION:
- 7 (i) HIS OR HER NAME AND ADDRESS AND, IF THAT PERSON DOES NOT
- 8 OWN THE DOG OR WOLF-DOG CROSS, THE NAME AND ADDRESS OF THE DOG'S OR
- 9 WOLF-DOG CROSS'S OWNER.
 - (ii) INFORMATION, IF KNOWN BY THAT PERSON, AS TO WHETHER THE

- 1 DOG OR WOLF-DOG CROSS IS CURRENT ON ALL LEGALLY REQUIRED
- 2 VACCINATIONS.
- 3 (B) IF A REASONABLE PERSON WOULD DETERMINE THAT THE INDIVIDUAL
- 4 WHO WAS BITTEN MAY REQUIRE MEDICAL ATTENTION, DO 1 OF THE
- 5 FOLLOWING:
- 6 (i) UNLESS ASSISTANCE IS REFUSED, ASSIST THE INDIVIDUAL IN
- 7 OBTAINING MEDICAL ATTENTION.
- 8 (ii) UNLESS ASSISTANCE IS REFUSED, INFORM A POLICE AGENCY OR
- 9 EMERGENCY SERVICES PROVIDER HAVING JURISDICTION OVER THE
- 10 GEOGRAPHICAL AREA IN WHICH THE BITE OCCURRED THAT MEDICAL ATTENTION
- 11 IS REOUIRED.
- 12 (2) A PERSON WHO KNOWS OR HAS REASON TO KNOW THAT A DOG OR
- 13 WOLF-DOG CROSS IN HIS OR HER CUSTODY HAS BITTEN ANY INDIVIDUAL
- 14 SHALL MAKE A DILIGENT SEARCH TO LOCATE THE INDIVIDUAL WHO WAS
- 15 BITTEN IF A SEARCH IS NECESSARY TO COMPLY WITH THE REQUIREMENTS OF

- 17 (3) EXCEPT AS PROVIDED IN SUBSECTION (2), A PERSON WHO KNOWS
- 18 OR HAS REASON TO KNOW THAT A DOG OR WOLF-DOG CROSS IN HIS OR HER
- 19 CUSTODY HAS BITTEN ANY INDIVIDUAL SHALL REMAIN ON THE SCENE UNTIL
- 20 THE REQUIREMENTS OF THIS SECTION ARE FULFILLED.
- 21 (4) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A
- 22 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 90 DAYS OR
- 23 A FINE OF NOT MORE THAN \$100.00, OR BOTH.
- 24 (5) AS USED IN THIS SECTION, "DOG" AND "WOLF-DOG CROSS" MEAN
- 25 THOSE TERMS AS DEFINED IN SECTION 2 OF THE WOLF-DOG CROSS ACT, 2000
