THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 44. (1) The state department shall pay a fee to an
- 2 attorney or other competent professional who represents a person in

- 4 administration in a proceeding establishing retroactive benefits
- 5 for that person under the supplemental security income for the

- 8 fee under this section only if the proceeding results in direct
- reimbursement to the department of interim assistance paid to the

- 1 person for the period covered by the award. Direct reimbursement
- 2 means a lump sum payment to the department from the social security
- 3 administration or from the person who received the interim
- 4 assistance. A fee shall not be paid under this section for a
- 5 reimbursement that results from an initial determination only, and
- 6 a fee paid shall not exceed the amount of interim assistance
- 7 reimbursed to the state -pursuant to UNDER that proceeding. A FEE
- 8 SHALL NOT BE PAID UNDER THIS SECTION IF THE SOCIAL SECURITY

- 21 THE NECESSARY STEPS TO BECOME ELIGIBLE FOR PAYMENTS BY THE SOCIAL
- 22 SECURITY ADMINISTRATION UNDER THE TITLE XVI CLAIM. A FEE SHALL NOT
- 23 BE PAID UNDER THIS SECTION IF THE PERSON APPLYING FOR BENEFITS HAS
- 24 PAID A FEE OR THE ATTORNEY OR REPRESENTATIVE IS ELIGIBLE FOR THE
