A bill to amend 2000 PA 322, entitled "Julian-Stille value-added act,"

(MCL 285.301 to 285.304) by adding section 2a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2A. (1) THE AGRICULTURAL DEVELOPMENT FUND IS CREATED AS A
- 2 REVOLVING FUND WITHIN THE DEPARTMENT OF TREASURY TO BE ADMINISTERED
- 3 BY THE DEPARTMENT. THE STATE TREASURER SHALL DIRECT THE INVESTMENT
- 4 OF THE FUND. MONEY IN THE FUND AT THE CLOSE OF THE FISCAL YEAR
- 5 SHALL REMAIN IN THE FUND AND SHALL NOT LAPSE TO THE GENERAL FUND.
- 6 THE DEPARTMENT MAY UTILIZE UP TO 4% OF THE FUND FOR ADMINISTRATIVE
- 7 PURPOSES. THE STATE TREASURER SHALL CREDIT TO THE FUND MONEY FROM
- 8 THE FOLLOWING SOURCES:
 - (A) APPROPRIATIONS.

- 1 (B) MONEY OR OTHER ASSETS FROM ANY SOURCE FOR DEPOSIT INTO THE

- 4 PROVIDED BY LAW.
- 5 (2) OF THE MONEY APPROPRIATED DURING FISCAL YEAR 2005-2006
- 6 FROM THE 21ST CENTURY JOBS TRUST FUND, NOT MORE THAN 25% SHALL BE
- 7 USED FOR GRANTS. THE MAXIMUM GRANT FROM THE FUND SHALL NOT EXCEED
- 8 \$250,000.00. THE MAXIMUM LOAN FROM THE FUND SHALL NOT EXCEED
- 9 \$500,000.00. NOT LESS THAN 50% SHALL BE AWARDED AS GRANTS AND LOANS
- 10 FOR SPECIALTY CROPS.
- 11 (3) THE DEPARTMENT OF TREASURY SHALL DEPOSIT NOT LESS THAN
- 12 \$5,000,000.00 OF THE REVENUE AVAILABLE WITHIN THE MICHIGAN CLEAN
- 13 AIR FUND CREATED UNDER SECTION 3(2) INTO THE AGRICULTURAL
- 14 DEVELOPMENT FUND UNDER SUBSECTION (1).
- 15 Enacting section 1. This amendatory act does not take effect
