SENATE BILL No. 1223

April 20, 2006, Introduced by Senators SWITALSKI, SCHAUER, OLSHOVE, CHERRY, JACOBS, BASHAM, BARCIA, BRATER and WHITMER and referred to the Committee on Government Operations.

A bill to amend 1968 PA 317, entitled

"An act relating to the conduct of public servants in respect to governmental decisions and contracts with public entities; to provide penalties for the violation of this act; to repeal certain acts and parts of acts; and to validate certain contracts,"

by amending sections 1, 3a, and 8 (MCL 15.321, 15.323a, and 15.328), section 3a as amended by 1996 PA 203 and section 8 as amended by 1997 PA 145.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 1. As used in this act:

(a) "Public servant" includes —all persons serving any public entity, except members of the legislature and state officers who are within the provisions of section 10 of article 4 of the state constitution as implemented by legislative act. ANY INDIVIDUAL SERVING A PUBLIC ENTITY WITHIN THIS STATE, EXCEPT THE FOLLOWING:

- 3 (ii) AN INDIVIDUAL SUBJECT TO THE ETHICS ACT FOR EXECUTIVE

- 5 (iii) AN INDIVIDUAL SUBJECT TO THE LEGISLATIVE ETHICS ACT.
- 6 (b) "Public entity" means <u>the state including all agencies</u>
- 7 thereof, any public body corporate within the state, including all
- 8 agencies thereof, or any non-incorporated public body within the
- 9 state of whatever nature, including all agencies thereof THIS
- 10 STATE OR A PUBLIC OR GOVERNMENTAL ENTITY WITHIN THIS STATE,
- 11 INCLUDING, BUT NOT LIMITED TO, A DEPARTMENT, AGENCY, BRANCH,
- 12 POLITICAL SUBDIVISION, OR PUBLIC BODY CORPORATE OF THIS STATE, OR A
- 13 PUBLIC BODY CORPORATE OF 1 OR MORE POLITICAL SUBDIVISIONS OF THIS
- 14 STATE.
- 15 Sec. 3a. Section 2 shall not be construed to do any of the
- 16 following:
- 17 (a) Prohibit public servants of a city, village, township, or
- 18 county with a population of less than 25,000 from serving, with or
- 19 without compensation, as emergency medical services personnel as
- 20 defined in section 20904 of the public health code, Act No. 368 of
- 21 the Public Acts of 1978, being section 333.20904 of the Michigan
- 22 Compiled Laws 1978 PA 368, MCL 333.20904.
- 23 (b) Prohibit A public -servants SERVANT of a city, village,
- 24 township, or county with a population of less than 25,000 from
- 25 serving, with or without compensation, as a firefighter in that
- 26 city, village, township, or county if that firefighter is not any
- 27 of the following:

- 1 (i) A full-time firefighter.
- 2 (ii) A fire chief.
- 3 (iii) A person who negotiates with the city, village, township,
- 4 or county on behalf of the firefighters.
- 5 (c) Limit the authority of the governing body of a city,
- 6 village, township, or county with a population of less than 25,000
- 7 to authorize a public servant to perform, with or without
- 8 compensation, other additional services for the unit of local
- 9 government.
- 10 (d) Prohibit public servants of this state from purchasing at
- 11 a tax sale lands returned as delinquent for taxes under the general
- 12 property tax act, Act No. 206 of the Public Acts of 1893, being
- sections 211.1 to 211.157 of the Michigan Compiled Laws, unless
- 14 otherwise prohibited by the rules of the Michigan civil service
- 15 commission or the department or agency of which that public servant
- 16 is an employee.
- 17 Sec. 8. It is the intention that this act shall THIS ACT IS
- 18 INTENDED TO constitute the sole law in this state and shall
- 19 supersede all other acts in respect to RESPECTING conflicts of
- 20 interest relative to public contracts involving public
- 21 servants, -other than members of the legislature and state
- 22 officers, including but not limited to section 30 of 1851 PA 156,
- 23 MCL 46.30 AND SUPERSEDES ALL OTHER ACTS ON THE SUBJECT. This act
- 24 does not prohibit a unit of local government from adopting -an
- 25 ordinance or enforcing an -existing ordinance relating to
- 26 conflict of interest -in- ON subjects other than public contracts
- 27 involving public servants.
