September 5, 2006, Introduced by Senators GARCIA and GOSCHKA and referred to the Committee on Judiciary.

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"

(MCL 600.101 to 600.9947) by adding section 2912i.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2912I. (1) SUBJECT TO SUBSECTION (2), THE PLAINTIFF IN AN
- 2 ACTION ALLEGING MALPRACTICE OR NEGLIGENCE AGAINST AN ARCHITECT OR
- 3 ENGINEER SHALL FILE WITH THE COMPLAINT AN AFFIDAVIT OF MERIT SIGNED
- BY AN INDIVIDUAL WHO THE PLAINTIFF OR, IF THE PLAINTIFF IS
- 5 REPRESENTED BY AN ATTORNEY, THE PLAINTIFF'S ATTORNEY REASONABLY
- 6 BELIEVES MEETS THE REQUIREMENTS OF SUBSECTION (3). THE AFFIANT
- 7 SHALL STATE IN THE AFFIDAVIT OF MERIT ALL OF THE FOLLOWING:
 - (A) THAT HE OR SHE HAS REVIEWED ALL RECORDS SUPPLIED BY THE

- 5 (C) THAT IT IS HIS OR HER OPINION THAT THE APPLICABLE STANDARD
- 6 OF PRACTICE OR CARE WAS BREACHED BY THE ARCHITECT OR ENGINEER.
- 7 (D) A DETAILED DESCRIPTION OF THE ACTIONS THAT SHOULD HAVE
- 8 BEEN TAKEN OR OMITTED BY THE ARCHITECT OR ENGINEER TO HAVE COMPLIED
- 9 WITH THE APPLICABLE STANDARD OF PRACTICE OR CARE.
- 10 (E) THE MANNER IN WHICH THE BREACH OF THE STANDARD OF PRACTICE
- 11 OR CARE WAS THE PROXIMATE CAUSE OF THE ALLEGED INJURY TO THE
- 12 PLAINTIFF.
- 13 (2) ON MOTION OF A PARTY FOR GOOD CAUSE SHOWN, THE COURT IN
- 14 WHICH THE COMPLAINT IS FILED MAY GRANT THE PLAINTIFF AN ADDITIONAL
- 15 28 DAYS IN WHICH TO FILE THE AFFIDAVIT REQUIRED UNDER SUBSECTION
- 16 (1).
- 17 (3) TO QUALIFY TO SIGN AN AFFIDAVIT UNDER SUBSECTION (1), AN
- 18 INDIVIDUAL SHALL MEET BOTH OF THE FOLLOWING REQUIREMENTS:
- 19 (A) BE LICENSED IN THIS STATE OR ANOTHER STATE AS AN ARCHITECT
- 20 OR ENGINEER, AS APPLICABLE.
- 21 (B) DURING THE YEAR IMMEDIATELY PRECEDING THE DATE OF THE
- 22 CONDUCT THAT IS THE SUBJECT OF THE AFFIDAVIT, HAVE DEVOTED A
- 23 MAJORITY OF HIS OR HER PROFESSIONAL TIME TO 1 OR MORE OF THE
- 24 FOLLOWING:
- 25 (i) THE ACTIVE PRACTICE OF ARCHITECTURE OR ENGINEERING, AS
- 26 APPLICABLE.
- 27 (ii) THE INSTRUCTION OF STUDENTS IN AN ACCREDITED ARCHITECTURE
