SENATE BILL No. 1404

September 5, 2006, Introduced by Senators GOSCHKA, KUIPERS, JOHNSON, GILBERT, GARCIA and BARCIA and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

by amending sections 50c and 81d (MCL 750.50c and 750.81d), section 50c as amended by 2002 PA 672 and section 81d as added by 2002 PA 266.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 50c. (1) As used in this section:

- (a) "Dog handler" means a peace officer who has successfully completed training in the handling of a police dog pursuant to a policy of the law enforcement agency that employs that peace officer.
- (b) "Physical harm" means any injury to a dog's or horse's physical condition.
 - (c) "Police dog" means a dog used by a law enforcement agency

- 1 of this state or of a local unit of government of this state that
- 2 is trained for law enforcement work and subject to the control of a
- 3 dog handler.
- 4 (d) "Police horse" means a horse used by a law enforcement
- 5 agency of this state or of a local unit of government of this state

- 7 (E) "SEARCH AND RESCUE DOG" MEANS A DOG THAT IS TRAINED OR

- 13 (F) -(e) "Serious physical harm" means any injury to a dog's

- 16 that seriously impairs the function of a body organ or limb.
- 17 (2) A person shall not intentionally kill or cause serious
- 18 physical harm to a police dog or police horse OR A SEARCH AND
- 19 RESCUE DOG.
- 20 (3) A person shall not intentionally cause physical harm to a
- 21 police dog or police horse OR A SEARCH AND RESCUE DOG.
- 22 (4) A person shall not intentionally harass or interfere with
- 23 a police dog or police horse OR SEARCH AND RESCUE DOG lawfully
- 24 performing its duties.
- 25 (5) A person who violates subsection (2) is guilty of a felony
- 26 punishable by imprisonment for not more than -5 10 years or a fine

- 16 USED IN THIS SUBPARAGRAPH, "SEARCH AND RESCUE OPERATION" MEANS AN
- 17 EFFORT CONDUCTED AT THE DIRECTION OF AN AGENCY OF THIS STATE OR OF
- 18 A POLITICAL SUBDIVISION OF THIS STATE TO LOCATE OR RESCUE A LOST,
- 19 INJURED, OR DECEASED INDIVIDUAL.
- (c) "Serious impairment of a body function" means that term as
