ENROLLED HOUSE BILL No. 4307

AN ACT to make, supplement, and adjust appropriations for various state departments and agencies for the fiscal year ending September 30, 2005; to provide for the expenditure of the appropriations; and to repeal acts and parts of acts.

The People of the State of Michigan enact:

GENERAL SECTIONS

Sec. 201. (1) From the unreserved balance of the general fund for the fiscal year ending September 30, 2005, after all payments are made pursuant to section 701(2) of 2005 PA 11, an amount not to exceed \$8,850,000.00 is appropriated for the following:

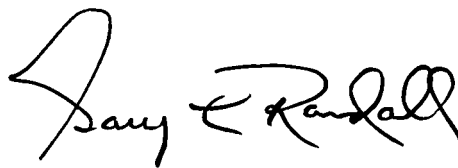
(2) If an insufficient general fund balance is available to support the line items identified in subsection (1), then all line items identified in subsection (1) shall be reduced proportionately according to the available balance.

(3) The line items identified in subsection (1) are established as work project accounts with the funds being available for expenditure in fiscal year 2005-2006 for the programs as indicated.

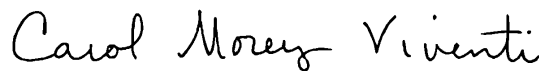
REPEALERS
