THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 109. (1) "Railroad" means a person, partnership,
- 2 association, or corporation, their respective lessees, trustees, or
- 3 receivers, appointed by a court, or other legal entity operating in
- 4 this state either as a common carrier for hire or for private use
- 5 as a carrier of persons or property upon cars operated upon
- 6 stationary rails and includes any person, partnership, association,
- 7 corporation, trustee, or receiver appointed by a court or any other
- 8 legal entity owning railroad tracks.

and by adding section 450.

- 9 (2) "Road authority" means a governmental agency having
- 10 jurisdiction over public streets and highways. Road authority

- 1 includes the department, any other state agency, and county, city,
- 2 and village governmental agencies responsible for the construction,
- 3 repair, and maintenance of streets and highways.
- 4 (3) "Serious impairment of a body function" means that term as
- 5 defined in section 58c of the Michigan vehicle code, 1949 PA 300,
- 6 MCL 257.58c.
- 7 (4) "Street railway" means an organization formed under the
- 8 laws of this state for the purpose of operating a street railway
- 9 system other than a railroad train for transporting persons or
- 10 property. A street railway system is operated upon rails
- 11 principally within a municipality utilizing streetcars, trolleys,
- 12 and trams for the transportation of persons or property. Such
- 13 organizations may accumulate, store, manufacture, conduct, use,
- 14 sell, furnish, and supply electricity and electric power. STREET

- 17 (5) "Street railway system" means the facilities, equipment,

- 22 (6) "Traffic control device" means a sign, signal, marking, or
- 23 other device placed on or adjacent to a street or highway by the
- 24 road authority having jurisdiction over that street or highway to
- 25 regulate, warn, or guide traffic.
- 26 (7) "Watchperson" means a railroad employee who is stationed
- 27 at an at-grade crossing to signal to operators of vehicles

- 1 approaching the crossing of the impending movement of a train or
- 2 other railroad on-track equipment over the crossing.
