GENERAL SECTIONS

Sec. 201. Pursuant to section 30 of article IX of the state
S03079'07 (H-9) JLB

22 Sec. 203. As used in this act:

23 (a) "Board" means the state administrative board.

24 (b) "Community college" does not include a state agency or
25 university.

26 (c) "Department" means the department of management and
27 budget.

1 (d) "Director" means the director of the department of
2 management and budget.

3 (e) "DAG" means the United States department of agriculture.

4 (f) "DHS" means the United States department of homeland
5 security.

6 (g) "DOD" means the United States department of defense.

7 (h) "DOI" means the United States department of interior.

8 (i) "DOT" means the United States department of
9 transportation.

10 (j) "Fiscal agencies" means the senate fiscal agency and the
11 house fiscal agency.

12 (k) "IDG" means interdepartmental grant.

13 (l) "JCOS" means the joint capital outlay subcommittee of the
14 appropriations committees.

15 (m) "LEED" means the United States green building council's
16 leadership in energy and environmental design green building rating
17 system.

18 (n) "State agency" means an agency of state government. State
19 agency does not include a community college or university.

20 (o) "State building authority" means the authority created
21 under 1964 PA 183, MCL 830.411 to 830.425.

22 (p) "University" means a 4-year university supported by the
23 state. University does not include a community college or a state
24 agency.

25 Sec. 204. Funds appropriated in part 1 shall not be used for
26 the purchase of foreign goods or services, or both, if
27 competitively priced and of comparable quality American goods or

1 services, or both, are available. Preference should be given to
2 goods or services, or both, manufactured or provided by Michigan
3 businesses if they are competitively priced and of comparable
4 quality.

5 Sec. 205. Unless otherwise specified, departments and agencies
6 receiving appropriations in part 1 shall use the Internet to
7 fulfill the reporting requirements of this act. This requirement
8 may include transmission of reports via electronic mail to the
9 recipients identified for each reporting requirement, or it may
10 include placement of reports on an Internet or Intranet site.

11 **DEPARTMENT OF AGRICULTURE**

12 Sec. 301. Of the amounts appropriated in part 1 for farmland
13 and open space development acquisition, the funds shall be used for
14 the purchase of development rights and the awarding of grants by
15 the agriculture preservation fund board under the natural resources
16 and environmental protection act, 1994 PA 451, MCL 324.101 to
17 324.90106.

18 **CAPITAL OUTLAY PROCESSES, PROCEDURES & REPORTS**

19 Sec. 401. Each capital outlay project authorized in this act
20 or any previous capital outlay act shall comply with the procedures
21 required by the management and budget act, 1984 PA 431, MCL 18.1101
22 to 18.1594.

23 Sec. 402. A statement of a proposed facility's operating cost
24 shall be included with the facility's program statement and
25 planning documents when the plans are presented to JCOS for

1 approval.

2 Sec. 403. (1) Before proceeding with final planning and
3 construction for projects at community colleges and universities
4 included in an appropriations act, the community college or
5 university shall sign an agreement with the department that
6 includes the following provisions:

7 (a) The university or community college agrees to construct
8 the project within the total authorized cost established by the
9 legislature pursuant to the management and budget act, 1984 PA 431,
10 MCL 18.1101 to 18.1594, and an appropriations act.

11 (b) The design and program scope of the project shall not
12 deviate from the design and program scope represented in the
13 program statement and preliminary planning documents approved by
14 the department.

15 (c) Any other items as identified by the department that are
16 necessary to complete the project.

17 (2) The department retains the authority and responsibility
18 normally associated with the prudent maintenance of the public's
19 financial and policy interests relative to the state-financed
20 construction projects managed by a community college or university.

21 Sec. 404. (1) The department shall provide the JCOS, the state
22 budget director, and the fiscal agencies with reports as considered
23 necessary relative to the status of each planning or construction
24 project financed by the state building authority, by this act, or
25 by previous acts.

26 (2) Before the end of each fiscal year, the department shall
27 report to the JCOS, the state budget director, and the fiscal

1 agencies for each capital outlay project other than lump sums all
2 of the following:

3 (a) The account number and name of each construction project.

4 (b) The balance remaining in each account.

5 (c) The date of the last expenditure from the account.

6 (d) The anticipated date of occupancy if the project is under
7 construction.

8 (e) The appropriations history for the project.

9 (f) The professional service contractor.

10 (g) The amount of a project financed with federal funds.

11 (h) The amount of a project financed through the state
12 building authority.

13 (i) The total authorized cost for the project and the state
14 authorized share if different than the total.

15 (3) Before the end of each fiscal year, the department shall
16 report the following for each project by a state agency,
17 university, or community college that is authorized for planning
18 but is not yet authorized for construction:

19 (a) The name of the project and account number.

20 (b) Whether a program statement is approved.

21 (c) Whether schematics are approved by the department.

22 (d) Whether preliminary plans are approved by the department.

23 (e) The name of the professional service contractor.

24 (4) As used in this section, "project" includes appropriation
25 line items made for purchase of real estate.

26 Sec. 405. A state agency, college, or university shall take
27 steps necessary to make available federal and other money indicated

3 in this act, and to use any part or all of the appropriations to
4 meet matching requirements that are considered to be in the best

7 matching requirements.

8 Sec. 409. (1) Before money is released for the construction or
9 lease of a capital outlay project costing over \$1,000,000.00, at
10 the request of JCOS the department shall submit to JCOS, with
11 preliminary planning documents, a detailed comparative cost
12 analysis. The cost analysis shall include a comparison of the
13 financial and other benefits of construction, financing, operation,
14 and maintenance of the proposed facility between all of the
15 following:

16 (a) The state.

17 (b) The private sector.

18 (c) A combination of the state and the private sector.

19 (d) A lease agreement.

20 (2) If the department's recommendation for financing is
21 inconsistent with the findings of the comparative cost analysis,
22 the department shall present written documentation to JCOS
23 outlining the rationale for the recommendation.

24 (3) For purposes of this section, "capital outlay project"
25 means a construction project or lease requiring JCOS approval
26 including, but not limited to, a general office facility, special
27 use facility, warehouse, institutional facility, or utility system

1 designed for use by a state agency or university. Capital outlay
2 project does not include a special maintenance and remodeling
3 project, grant-in-aid project, prison facility, legislative

6 Sec. 410. Pursuant to section 242(2) of the management and
7 budget act, 1984 PA 431, MCL 18.1242, the department shall submit
8 5-year capital outlay plans and capital outlay priority requests
9 developed by state agencies (and as approved by the department of
10 management and budget), universities, and community colleges to the
11 chairperson and ranking vice-chairperson of JCOS and the fiscal
12 agencies upon the release of the executive budget recommendation.

13 **STATE AGENCY LUMP SUMS**

14 Sec. 501. (1) The directors of respective departments shall
15 allocate lump-sum appropriations made in this act consistent with

18 or facility needs and may include, but are not limited to, design,

2 **COLLEGES AND UNIVERSITIES**

3 Sec. 601. (1) This section applies only to projects for
4 community colleges.

5 (2) State support is directed towards the remodeling and
6 additions, special maintenance, or construction of certain
7 community college buildings. The community college shall obtain or
8 provide for site acquisition and initial main utility installation
9 to operate the facility. Funding shall be comprised of local and
10 state shares, and the state share shall include 50% of any federal
11 money awarded for projects appropriated in this act. Not more than
12 50% of a capital outlay project, not including a lump-sum special
13 maintenance project or remodeling and addition project, for a
14 community college shall be appropriated from state and federal
15 funds, unless otherwise appropriated by the legislature.

16 (3) An expenditure under this act is authorized when the
17 release of the appropriation is approved by the board upon the
18 recommendation of the director. The director may recommend to the
19 board the release of any appropriation in part 1 only after the
20 director is assured that the legal entity operating the community
21 college to which the appropriation is made has complied with this
22 act and has matched the amounts appropriated as required by this
23 act. A release of funds in part 1 shall not exceed 50% of the total
24 cost of planning and construction of any project, not including
25 lump-sum remodeling and additions and special maintenance, unless
26 otherwise appropriated by the legislature. Further planning and

1 construction of a project authorized by this act or applicable
2 sections of the management and budget act, 1984 PA 431, MCL 18.1101
3 to 18.1594, shall be in accordance with the purpose and scope as
4 defined and delineated in the approved program statements and
5 planning documents. This act is applicable to all projects for
6 which planning appropriations were made in previous acts.

7 (4) The community college shall take the steps necessary to
8 secure available federal construction and equipment money for
9 projects funded for construction in this act if an application was
10 not previously made. If there is a reasonable expectation that a
11 prior year unfunded application may receive federal money in a
12 subsequent year, the college shall take whatever action necessary
13 to keep the application active. If federal money is received, the
14 state share shall be adjusted accordingly as provided by this act.

15 Sec. 602. If matching revenues are received in an amount less
16 than the appropriations contained in this act, the state funds of
17 the appropriation shall be reduced in proportion to the amount of
18 matching revenue received.

19 Sec. 603. (1) The director may require that community colleges
20 and universities that have an authorized project listed in part 1
21 submit documentation regarding the project match and governing
22 board approval of the authorized project not more than 60 days
23 after the beginning of the fiscal year.

24 (2) If the documentation required by the director under
25 subsection (1) is not submitted, or does not adequately
26 authenticate the availability of the project match or board
27 approval of the authorized project, the authorization may

16 **DEPARTMENT OF MANAGEMENT AND BUDGET**

17 Sec. 681. (1) The department shall provide JCOS and the fiscal
18 agencies a report, not more than 15 days after the reporting date,
19 of privately owned leased space by state agencies, by September 30
20 of each year, consisting of the following:

- 21 (a) Department.
- 22 (b) Agency division and leased number.
- 23 (c) Building location (address and city).
- 24 (d) Type of building.
- 25 (e) County.

1 (f) Name and address of lessor.

2 (g) Square footage and net square footage rate.

3 (h) Monthly and annual cost.

4 (i) Date lease started and expires.

5 (j) Options and services.

6 (k) Total monthly and annual cost for all leases.

7 (2) The lease report shall be summarized for office space,
8 group homes, and other space for the Lansing area and statewide,
9 excepting the Lansing area.

10 Sec. 682. (1) A state agency shall provide notification to
11 JCOS prior to commencing a demolition project not authorized by
12 law. The demolition project may be disapproved by JCOS within 30
13 days after the date of notification, and if disapproved within that
14 time, the demolition project shall not be authorized. The
15 notification to JCOS shall identify the building or facility to be
16 demolished and its location, the estimated cost of the demolition
17 project, estimated project schedule, and the source of financing.

18 (2) The 30-day disapproval period does not apply to any
19 notifications submitted during a period when the legislature will
20 not be in session for 15 days or more. In these situations, the 30-
21 day disapproval period begins on the first scheduled session day.

22 Sec. 683. Pursuant to department policy, state agencies may
23 expend not more than \$1,000,000.00 from their operating budget for
24 special maintenance, remodeling, additions, or other capital outlay
25 purposes, unless specifically authorized by the legislature, for
26 those purposes.

1 **DEPARTMENT OF MILITARY AND VETERANS AFFAIRS**

2 Sec. 701. The appropriations in part 1 for the department of
3 military and veterans affairs design and construction projects are
4 contingent upon the availability of federal and state restricted
5 funds for financing.

6 **DEPARTMENT OF NATURAL RESOURCES**

7 Sec. 801. The appropriation made in this act for the harbors
8 and docks program is for the purpose of participating with the
9 federal government and assisting political entities and
10 subdivisions of this state in the construction and improvement of
11 recreational boating facilities within this state. Subject to the
12 approval of the board, this money shall be allocated by the
13 department of natural resources to the federal government or to the
14 political entities or local units of government involved in the
15 particular projects. An allocation shall not exceed the state
16 portion as listed with each project description. The department of
17 natural resources shall take the steps necessary to match federal
18 money available for the construction and improvement of
19 recreational boating facilities within this state and to meet
20 requirements of the federal government.

21 Sec. 802. The department of natural resources shall require
22 local units of government to enter into agreements with the
23 department for the purpose of administering the natural resources
24 trust fund grants appropriated in part 1. Among other provisions,
25 the agreements shall require that grant recipients agree to
26 dedicate to public outdoor recreation uses in perpetuity the land

1 acquired or developed; to replace lands converted or lost to other
2 than public outdoor recreation use; and, for parcels acquired that
3 are over 5 or more acres in size, to provide the state with a
4 nonparticipating 1/6 minimum royalty interest in any acquired
5 minerals that are retained by the grant recipient. The agreements
6 shall also provide that the full payments of grants can be made
7 only after proof of acquisition, or completion of the development
8 project, is submitted by the grant recipient and all costs are
9 verified by the department of natural resources.

10 Sec. 803. Before the end of each fiscal year, the department
11 of natural resources shall report each year to JCOS the status of
12 each project that received an appropriation in any capital outlay
13 act, if the project is either not completed or has a balance
14 remaining in its account. The report shall be in the same form and
15 contain the information as required under section 504. The report
16 shall be separated into the following areas, by fund sources:

- 17 (a) Waterways projects.
18 (b) Urban recreation projects.
19 (c) State park projects.
20 (d) Wildlife and fisheries projects.
21 (e) Other projects.

22 **STATE TRANSPORTATION DEPARTMENT**

23 Sec. 901. (1) From federal-state-local project appropriations
24 contained in part 1 for the purpose of assisting political entities
25 and subdivisions of this state in the construction and improvement
26 of publicly used airports and landing fields within this state, the

1 state transportation department may permit the award of contracts
2 on behalf of units of local government for the authorized locations
3 not to exceed the indicated amounts, of which the state allocated
4 portion shall not exceed the amount appropriated in part 1.

5 (2) Political entities and subdivisions shall provide not less
6 than 2.5% of the cost of any project under this section, unless a
7 total nonfederal share greater than 5% is otherwise specified in
8 federal law. State money shall not be allocated until local money
9 is allocated. State money for any 1 project shall not exceed 1/3 of
10 the total appropriation in part 1 from state funds for airport
11 improvement programs.

12 (3) The Michigan aeronautics commission may take those steps
13 necessary to match federal money available for airport construction
14 and improvement within this state and to meet the matching
15 requirements of the federal government. Whether acting alone or
16 jointly with another political subdivision or public agency or with
17 this state, a political subdivision or public agency of this state
18 shall not submit to any agency of the federal government a project
19 application for airport planning or development unless it is
20 authorized in this act and the project application is approved by
21 the governing body of each political subdivision or public agency
22 making the application and by the Michigan aeronautics commission.

23 Sec. 902. Before the end of each fiscal year, the state
24 transportation department shall report to JCOS the status of
25 projects funded in part 1 with the estimated dollars allocated for
26 each project. If there has to be a delay in reporting, the state
27 transportation department shall notify JCOS in writing of the date

10 **MISCELLANEOUS**

11 Sec. 1001. (1) Revenue collected from licenses issued under
12 the antenna site management project shall be deposited into the
13 antenna site management revolving fund created for this purpose in
14 the department of information technology. The department may
15 receive and expend funds from the fund for costs associated with
16 the antenna site management project, including the cost of a third-
17 party site manager. Any excess revenue remaining in the fund at the
18 close of the fiscal year shall be proportionately transferred to
19 the appropriate state restricted funds as designated in statute or
20 by constitution.

21 (2) An antenna shall not be sited pursuant to this section
22 without prior compliance with the respective local zoning codes and
23 local unit of government processes.
