HOUSE SUBSTITUTE FOR SENATE BILL NO. 633

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 43537 (MCL 324.43537), as amended by 1996 PA 585.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 43537. (1) A resident who is declared legally blind is
- 2 eligible to purchase a senior restricted or senior all-species
- 3 fishing license. The department may demand proof of blindness. The
- 4 licensee, when fishing, shall possess proof of blindness and shall
- 5 furnish the proof upon the request of a peace officer.
- 6 (2) A resident who has been determined by the United States
- 7 department of veterans affairs to be permanently and totally
- 8 disabled and entitled to veteran benefits at the 100% rate, for a
- 9 disability other than blindness, DISABLED VETERAN is eligible to
- 10 purchase any senior hunting license as described in section 43535

- 1 or any senior fishing license described in section 43536, or both.
- 2 (3) AS A PILOT PROJECT FOR 2007, THERE SHALL BE A DISABLED
- 3 VETERANS FIREARM DEER SEASON IN AT LEAST 3 AREAS OF THIS STATE,
- 4 INCLUDING MARQUETTE COUNTY AND DEER MANAGEMENT UNITS 053 AND 064.
- 5 THE DISABLED VETERANS FIREARM DEER SEASON SHALL CORRESPOND WITH THE
- 6 YOUTH FIREARM DEER HUNTING DAYS, IF ANY, ESTABLISHED BY ORDER OF
- 7 THE COMMISSION. A DISABLED VETERAN MAY TAKE 1 DEER DURING THE
- 8 DISABLED VETERANS FIREARM DEER SEASON. A DISABLED VETERAN TAKING
- 9 DEER DURING THIS SEASON SHALL POSSESS A CURRENT FIREARM DEER
- 10 LICENSE, COMBINATION DEER LICENSE, OR ANTLERLESS DEER LICENSE OR A
- 11 DEER MANAGEMENT ASSISTANCE PERMIT AUTHORIZING THE DISABLED VETERAN
- 12 TO TAKE A DEER WITH A FIREARM AND ISSUED FOR THE AREA OR LAND UPON
- 13 WHICH THE VETERAN IS HUNTING. THE SAME KIND OF DEER MAY BE TAKEN
- 14 DURING THE DISABLED VETERANS FIREARM DEER SEASON AS DURING THE
- 15 REGULAR NOVEMBER FIREARM DEER SEASON. THIS SUBSECTION DOES NOT
- 16 LIMIT THE AUTHORITY OF THE COMMISSION UNDER SECTION 40113A TO
- 17 ESTABLISH A SPECIAL HUNTING SEASON IN ANY AREA OF THIS STATE FOR
- 18 VETERANS WITH DISABILITIES OR OTHER CLASSES OF INDIVIDUALS.
- 19 (4) The department may demand proof of eliqibility under this
- 20 subsection (2) OR (3). The licensee, when hunting or taking aquatic
- 21 species, AS APPLICABLE, shall possess proof of his or her
- 22 eligibility under this subsection (2) OR (3) and shall furnish the
- 23 proof upon the request of a peace officer.
- 24 (5) (3)—The department shall process licenses issued under
- 25 this section SUBSECTION (2) in the same manner as licenses issued
- 26 to senior citizens for purposes of receiving appropriations from
- 27 the legislature under section 43546.

- (6) AS USED IN THIS SECTION, "DISABLED VETERAN" MEANS EITHER 1
- 2 OF THE FOLLOWING:
- (A) A RESIDENT WHO HAS BEEN DETERMINED BY THE UNITED STATES 3
- DEPARTMENT OF VETERANS AFFAIRS TO BE PERMANENTLY AND TOTALLY
- DISABLED AS A RESULT OF MILITARY SERVICE AND ENTITLED TO VETERANS' 5
- BENEFITS AT THE 100% RATE, FOR A DISABILITY OTHER THAN BLINDNESS. 6
- (B) A RESIDENT RATED BY THE UNITED STATES DEPARTMENT OF 7
- VETERANS AFFAIRS AS INDIVIDUALLY UNEMPLOYABLE. 8
