THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1138. (1) IF A PUPIL IS ABSENT FROM SCHOOL FOR UP TO 1
- 2 FULL SCHOOL DAY BECAUSE HIS OR HER PARENT[, LEGAL GUARDIAN, OR SIBLING]
- 4 SERVICE MEMBER BEING DEPLOYED ON OR RETURNING FROM ACTIVE DUTY, [OR IF A PUPIL IS ABSENT FROM SCHOOL FOR UP TO 2 FULL SCHOOL DAYS IF THE LOCATION OF THE DEPLOYMENT OR RETURN IS MORE THAN 300 MILES FROM THE PUPIL'S HOME,] THE
- 5 SCHOOL OFFICIALS OF A PUBLIC SCHOOL SHALL CONSIDER THAT ABSENCE TO
- 6 BE AN EXCUSED ABSENCE. THE BOARD OF A SCHOOL DISTRICT OR
- 7 INTERMEDIATE SCHOOL DISTRICT OR BOARD OF DIRECTORS OF A PUBLIC
- 8 SCHOOL ACADEMY SHALL ENSURE THAT THEIR ATTENDANCE POLICY IS
