

HOUSE BILL No. 4313

A bill to amend 1978 PA 472, entitled

"An act to regulate political activity; to regulate lobbyists, lobbyist agents, and lobbying activities; to require registration of lobbyists and lobbyist agents; to require the filing of reports; to prescribe the powers and duties of the department of state; to prescribe penalties; and to repeal certain acts and parts of acts,"

by amending section 6a (MCL 4.416a), as added by 1994 PA 383.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 6a. (1) A FORMER MEMBER OF THE MICHIGAN SENATE OR HOUSE
2 OF REPRESENTATIVES OR A FORMER GOVERNOR, LIEUTENANT GOVERNOR,
3 ATTORNEY GENERAL, OR SECRETARY OF STATE SHALL NOT MAKE EXPENDITURES
4 FOR OR RECEIVE COMPENSATION FOR LOBBYING [THAT IS EQUAL TO OR EXCEEDS THE
5 MONETARY THRESHOLD REQUIRED FOR REGISTERING AS A LOBBYIST AGENT] FOR 1
6 YEAR IMMEDIATELY
7 FOLLOWING THE END OF THE TERM OF OFFICE TO WHICH HE OR SHE WAS
8 ELECTED.
- 7 (2) A PERSON WHO HOLDS A NONELECTIVE POSITION OF HEAD OF A
