## SUBSTITUTE FOR HOUSE BILL NO. 4627

A bill to amend 1976 PA 453, entitled "Elliott-Larsen civil rights act,"

(MCL 37.2101 to 37.2804) by adding section 202b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 202B. (1) THE COMMISSION ON PAY EQUITY IS CREATED IN THE
- 2 MICHIGAN DEPARTMENT OF CIVIL RIGHTS AND IS RESPONSIBLE FOR THE
- 3 DEVELOPMENT OF DEFINITIONS OF COMPARABLE WAGES, USING THE CRITERIA
- 4 OF COMPOSITE SKILLS, RESPONSIBILITY, EFFORT, EDUCATION OR TRAINING,
- 5 AND WORKING CONDITIONS.
- 6 (2) THE GOVERNOR SHALL APPOINT THE MEMBERS OF THE COMMISSION
- 7 ON PAY EQUITY. THE COMMISSION IS COMPOSED OF THE FOLLOWING MEMBERS:
- 8 (A) THE DIRECTOR OF THE MICHIGAN DEPARTMENT OF CIVIL RIGHTS OR
- 9 HIS OR HER DESIGNEE.

- 1 (B) THE DIRECTOR OF THE MICHIGAN ECONOMIC DEVELOPMENT
- 2 CORPORATION OR HIS OR HER DESIGNEE.
- 3 (C) A REPRESENTATIVE OF THE MICHIGAN WOMEN'S COMMISSION.
- 4 (D) A REPRESENTATIVE OF THE MICHIGAN CHAMBER OF COMMERCE.
- 5 (E) A REPRESENTATIVE OF THE MICHIGAN AFL-CIO.
- 6 (F) A REPRESENTATIVE OF THE UNITED AUTO WORKERS.
- 7 (G) A REPRESENTATIVE OF THE MICHIGAN SMALL BUSINESS
- 8 ASSOCIATION.
- 9 (H) A REPRESENTATIVE OF THE NATIONAL ORGANIZATION FOR WOMEN,
- 10 MICHIGAN.
- 11 (I) A REPRESENTATIVE OF THE MICHIGAN WOMEN'S STUDIES
- 12 ASSOCIATION.
- 13 (J) A REPRESENTATIVE OF THE MICHIGAN FARM BUREAU.
- 14 (3) THE DIRECTOR OF THE MICHIGAN DEPARTMENT OF CIVIL RIGHTS OR
- 15 HIS OR HER DESIGNEE SHALL SERVE AS THE CHAIRPERSON OF THE
- 16 COMMISSION ON PAY EQUITY AND SHALL HAVE RESPONSIBILITY FOR
- 17 CONVENING THE MEETINGS OF THE COMMISSION, SETTING THE AGENDA FOR
- 18 ALL MEETINGS, AND PREPARING ALL MINUTES AND REPORTS OF THE WORK OF
- 19 THE COMMISSION.
- 20 (4) THE COMMISSION ON PAY EQUITY SHALL HOLD MEETINGS AND
- 21 HEARINGS AS NECESSARY TO DEVELOP DEFINITIONS, MODELS, AND
- 22 GUIDELINES FOR EMPLOYERS AND EMPLOYEES ON PAY EQUITY.
- 23 (5) THE COMMISSION ON PAY EQUITY SHALL PRESENT ITS FINDINGS
- 24 AND RECOMMENDATIONS TO THE LEGISLATURE, THE GOVERNOR, AND THE
- 25 PUBLIC BY A DATE NOT LATER THAN 1 YEAR AFTER THE GOVERNOR APPOINTS
- 26 ITS MEMBERS.
- 27 (6) ALL MEETINGS OF THE COMMISSION ON PAY EQUITY ARE SUBJECT

- 1 TO THE OPEN MEETINGS ACT, 1976 PA 267, MCL 15.261 TO 15.275, AND
- 2 THE FREEDOM OF INFORMATION ACT, 1976 PA 442, MCL 15.231 TO 15.246.
