- 4 FOR THE FULL AMOUNT OF LOSS SUFFERED BY THE VICTIM. IN ADDITION TO
- 5 RESTITUTION ORDERED UNDER SECTION 16, THE COURT [MAY] ORDER THE
- 6 DEFENDANT TO PAY ALL OF THE FOLLOWING:
- 7 (A) LOST INCOME, CALCULATED BY WHICHEVER OF THE FOLLOWING
 - METHODS RESULTS IN THE LARGEST AMOUNT:
 - (i) THE GROSS AMOUNT RECEIVED BY THE DEFENDANT FROM OR THE
 - VALUE TO THE DEFENDANT OF THE VICTIM'S LABOR OR SERVICES.
