A bill to amend 1994 PA 451, entitled

by amending sections 32705 and 32706 (MCL 324.32705 and 324.32706),

by 1996 PA 434, and by adding sections 32706a, 32706b, 32706c,
32706d, and 32706e.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 32705. (1) Except as otherwise provided in this section,
- 2 the owner of real property who has the INTENDS TO DEVELOP capacity
- 3 on that property to make a **NEW OR INCREASED** large quantity
- 4 withdrawal from the waters of this state shall register THE
- 5 WITHDRAWAL with the department AFTER USING THE ASSESSMENT TOOL, IF
- 6 REQUIRED UNDER THIS PART, AND prior to beginning that withdrawal. A

- 15 (E) THE DEPTH OF THE WITHDRAWAL IF FROM GROUNDWATER.
- 16 (F) THE AMOUNT AND RATE OF WATER TO BE WITHDRAWN.
- 17 (G) WHETHER THE WITHDRAWAL WILL BE INTERMITTENT.
- 18 (4) THE ASSESSMENT TOOL SHALL CONTAIN A PRINT FUNCTION THAT
- 19 ALLOWS THE USER, UPON RECEIPT OF THE ASSESSMENT TOOL'S
- 20 DETERMINATION, TO PRINT THE DATA SUBMITTED AND THE DETERMINATION
- 21 RETURNED ALONG WITH A DATE AND TIME.
- 22 (5) THE ASSESSMENT TOOL SHALL WORK IN CONJUNCTION WITH THE
- 23 ONLINE REGISTRATION PROCESS AND SHALL ALSO ALLOW OPERATION
- 24 INDEPENDENT OF THE ONLINE REGISTRATION PROCESS.
- 25 (6) ON AN ONGOING BASIS, THE DEPARTMENT SHALL ADD VERIFIED
- 26 DATA TO THE ASSESSMENT TOOL'S DATABASE FROM REPORTS SUBMITTED UNDER
- 27 SECTIONS 32707, WATER USE CONSERVATION PLANS SUBMITTED UNDER

- 5 RIVER SYSTEM, OR A ZONE C OR ZONE D WITHDRAWAL, THE PROPERTY OWNER
- 6 SHALL SUBMIT TO THE DEPARTMENT A REQUEST FOR A SITE-SPECIFIC
- 7 REVIEW. ADDITIONALLY, IF THE ASSESSMENT TOOL DETERMINES THAT A
- 8 PROPOSED WITHDRAWAL IS A ZONE A WITHDRAWAL, OR A ZONE B WITHDRAWAL

- 27 (2) UPON RECEIPT OF A REQUEST FOR A SITE-SPECIFIC REVIEW, THE

- 1 DEPARTMENT SHALL CONSIDER THE INFORMATION SUBMITTED TO THE
- 2 DEPARTMENT UNDER SUBSECTION (1) AND SHALL CONSIDER THE ACTUAL
- 3 STREAM OR RIVER FLOW DATA OF ANY AFFECTED STREAM REACH. THE
- 4 DEPARTMENT SHALL ALSO APPLY THE DRAINAGE AREA AGGREGATION STANDARDS
