by amending section 30 (MCL 206.30), as amended by 2005 PA 214.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 30. (1) "Taxable income" means, for a person other than
- 2 a corporation, estate, or trust, adjusted gross income as defined
- 3 in the internal revenue code subject to the following adjustments
- 4 under this section:

- 5 (a) Add gross interest income and dividends derived from
- 6 obligations or securities of states other than Michigan, in the
- 7 same amount that has been excluded from adjusted gross income
- 8 less related expenses not deducted in computing adjusted gross
  - income because of section 265(a)(1) of the internal revenue code.
    - (b) Add taxes on or measured by income to the extent the

- 1 taxes have been deducted in arriving at adjusted gross income.
- 2 (c) Add losses on the sale or exchange of obligations of the
- 3 United States government, the income of which this state is
- 4 prohibited from subjecting to a net income tax, to the extent
- 5 that the loss has been deducted in arriving at adjusted gross
- 6 income.
- 7 (d) Deduct, to the extent included in adjusted gross income,
- 8 income derived from obligations, or the sale or exchange of
- 9 obligations, of the United States government that this state is
- 10 prohibited by law from subjecting to a net income tax, reduced by
- 11 any interest on indebtedness incurred in carrying the obligations
- 12 and by any expenses incurred in the production of that income to
- 13 the extent that the expenses, including amortizable bond
- 14 premiums, were deducted in arriving at adjusted gross income.
- (e) Deduct, to the extent included in adjusted gross income,
- 16 compensation, including retirement benefits, received for

- 8 apportionment provisions of chapter 3.
- 9 (j) Deduct political contributions as described in section 4
- 10 of the Michigan campaign finance act, 1976 PA 388, MCL 169.204,
- 11 or 2 USC 431, not in excess of \$50.00 per annum, or \$100.00 per
- 12 annum for a joint return.
- 13 (k) Deduct, to the extent included in adjusted gross income,
- 14 wages not deductible under section 280C of the internal revenue
- **15** code.
- (l) Deduct the following payments made by the taxpayer in the
- 17 tax year:
- 18 (i) The amount of payment made under an advance tuition
- 19 payment contract as provided in the Michigan education trust act,
- 20 1986 PA 316, MCL 390.1421 to 390.1442.
- 21 (ii) The amount of payment made under a contract with a
- 22 private sector investment manager that meets all of the following
- 23 criteria:
- 24 (A) The contract is certified and approved by the board of
- 25 directors of the Michigan education trust to provide equivalent
- 26 benefits and rights to purchasers and beneficiaries as an advance
- 27 tuition payment contract as described in subparagraph (i).

- 1 (B) The contract applies only for a state institution of
- 2 higher education as defined in the Michigan education trust act,
- 3 1986 PA 316, MCL 390.1421 to 390.1442, or a community or junior
- 4 college in Michigan.
- 5 (C) The contract provides for enrollment by the contract's
- 6 qualified beneficiary in not less than 4 years after the date on

- 10 (I) The purchaser has had his or her offer to enter into an
- 11 advance tuition payment contract rejected by the board of

- 13 determines that the trust cannot accept an unlimited number of
- 14 enrollees upon an actuarially sound basis.
- 15 (II) The board of directors of the Michigan education trust
- 16 determines that the trust can accept an unlimited number of
- 17 enrollees upon an actuarially sound basis.
- 18 (m) If an advance tuition payment contract under the
- 19 Michigan education trust act, 1986 PA 316, MCL 390.1421 to
- 20 390.1442, or another contract for which the payment was
- 21 deductible under subdivision (l) is terminated and the qualified
- 22 beneficiary under that contract does not attend a university,
- 23 college, junior or community college, or other institution of
- 24 higher education, add the amount of a refund received by the
- 25 taxpayer as a result of that termination or the amount of the
- **26** deduction taken under subdivision (l) for payment made under that
- 27 contract, whichever is less.

- 1 (n) Deduct from the taxable income of a purchaser the amount
- 2 included as income to the purchaser under the internal revenue
- 3 code after the advance tuition payment contract entered into
- 4 under the Michigan education trust act, 1986 PA 316, MCL 390.1421
- 5 to 390.1442, is terminated because the qualified beneficiary
- 6 attends an institution of postsecondary education other than
- 7 either a state institution of higher education or an institution
- 8 of postsecondary education located outside this state with which
- 9 a state institution of higher education has reciprocity.
- 10 (o) Add, to the extent deducted in determining adjusted
- 11 gross income, the net operating loss deduction under section 172
- 12 of the internal revenue code.
- 13 (p) Deduct a net operating loss deduction for the taxable
- 14 year as determined under section 172 of the internal revenue code
- 15 subject to the modifications under section 172(b)(2) of the
- 16 internal revenue code and subject to the allocation and
- 17 apportionment provisions of chapter 3 of this act for the taxable
- 18 year in which the loss was incurred.
- 19 (q) For a tax year beginning after 1986, deduct, to the
- 20 extent included in adjusted gross income, benefits from a
- 21 discriminatory self-insurance medical expense reimbursement plan.
- (r) After September 30, 1994 and before the 1997 tax year, a
- 23 taxpayer who is a senior citizen may deduct, to the extent
- 24 included in adjusted gross income, interest and dividends
- 25 received in the tax year not to exceed \$1,000.00 for a single
- 26 return or \$2,000.00 for a joint return. However, for tax years
- 27 before the 1997 tax year, the deduction under this subdivision

- 1 shall not be taken if the taxpayer takes a deduction for
- 2 retirement benefits under subdivision (e) or a deduction under
- 3 subdivision (f) (i), (ii), (iv), or (v). For tax years after the 1996
- 4 tax year, a taxpayer who is a senior citizen may deduct to the
- 5 extent included in adjusted gross income, interest, dividends,
- 6 and capital gains received in the tax year not to exceed
- 7 \$3,500.00 for a single return and \$7,000.00 for a joint return
- 8 for the 1997 tax year, and \$7,500.00 for a single return and
- 9 \$15,000.00 for a joint return for tax years after the 1997 tax
- 10 year. For tax years after the 1996 tax year, the maximum amounts
- 11 allowed under this subdivision shall be reduced by the amount of
- 12 a deduction claimed for retirement benefits under subdivision (e)
- 13 or a deduction claimed under subdivision (f)(i), (ii), (iv), or (v).
- 14 For the 1995 tax year, for the 1996 tax year, and for each tax
- 15 year after the 1998 tax year, the maximum amounts allowed under
- 16 this subdivision shall be adjusted by the percentage increase in
- 17 the United States consumer price index for the immediately
- 18 preceding calendar year. The department shall annualize the
- 19 amounts provided in this subdivision as necessary for tax years
- 20 that end after September 30, 1994. As used in this subdivision,
- 21 "senior citizen" means that term as defined in section 514.
- (s) Deduct, to the extent included in adjusted gross income,
- 23 all of the following:
- 24 (i) The amount of a refund received in the tax year based on
- 25 taxes paid under this act.
- 26 (ii) The amount of a refund received in the tax year based on
- 27 taxes paid under the city income tax act, 1964 PA 284, MCL

- 1 141.501 to 141.787.
- 2 (iii) The amount of a credit received in the tax year based on
- 3 a claim filed under sections 520 and 522 to the extent that the
- 4 taxes used to calculate the credit were not used to reduce
- 5 adjusted gross income for a prior year.
- 6 (t) Add the amount paid by the state on behalf of the
- 7 taxpayer in the tax year to repay the outstanding principal on a
- 8 loan taken on which the taxpayer defaulted that was to fund an
- 9 advance tuition payment contract entered into under the Michigan
- 10 education trust act, 1986 PA 316, MCL 390.1421 to 390.1442, if
- 11 the cost of the advance tuition payment contract was deducted
- 12 under subdivision (l) and was financed with a Michigan education
- 13 trust secured loan.
- 14 (u) For the 1998 tax year and each tax year after the 1998
- 15 tax year, deduct the amount calculated under section 30d.
- 16 (v) For tax years that begin on and after January 1, 1994,
- 17 deduct, to the extent included in adjusted gross income, any
- 18 amount, and any interest earned on that amount, received in the
- 19 tax year by a taxpayer who is a Holocaust victim as a result of a
- 20 settlement of claims against any entity or individual for any
- 21 recovered asset pursuant to the German act regulating unresolved
- 22 property claims, also known as Gesetz zur Regelung offener
- 23 Vermogensfragen, as a result of the settlement of the action
- 24 entitled In re: Holocaust victim assets litigation, CV-96-4849,
- 25 CV-96-5161, and CV-97-0461 (E.D. NY), or as a result of any
- 26 similar action if the income and interest are not commingled in
- 27 any way with and are kept separate from all other funds and

- 1 assets of the taxpayer. As used in this subdivision:
- 2 (i) "Holocaust victim" means a person, or the heir or
- 3 beneficiary of that person, who was persecuted by Nazi Germany or
- 4 any Axis regime during any period from 1933 to 1945.
- 5 (ii) "Recovered asset" means any asset of any type and any
- 6 interest earned on that asset including, but not limited to, bank
- 7 deposits, insurance proceeds, or artwork owned by a Holocaust
- 8 victim during the period from 1920 to 1945, withheld from that
- 9 Holocaust victim from and after 1945, and not recovered,
- 10 returned, or otherwise compensated to the Holocaust victim until
- **11** after 1993.
- 12 (w) For tax years that begin after December 31, 1999,
- 13 deduct, to the extent not deducted in determining adjusted gross
- 14 income, both of the following:
- 15 (i) The total of all contributions CONTRIBUTIONS made on and
- 16 after October 1, 2000 by the taxpayer in the tax year less
- 17 qualified withdrawals made in the tax year to-FROM education
- 18 savings accounts, CALCULATED ON A PER EDUCATION SAVINGS ACCOUNT
- 19 BASIS, pursuant to the Michigan education savings program act,
- 20 2000 PA 161, MCL 390.1471 to 390.1486, not to exceed A TOTAL
- 21 **DEDUCTION OF** \$5,000.00 for a single return or \$10,000.00 for a
- 22 joint return per tax year. THE AMOUNT CALCULATED UNDER THIS
- 23 SUBPARAGRAPH FOR EACH EDUCATION SAVINGS ACCOUNT SHALL NOT BE LESS
- 24 THAN ZERO.
- 25 (ii) The amount under section 30f.
- 26 (x) For tax years that begin after December 31, 1999, add,
- 27 to the extent not included in adjusted gross income, the amount

- 1 of money withdrawn by the taxpayer in the tax year from education
- 2 savings accounts, not to exceed the total amount deducted under
- 3 subdivision (w) in the tax year and all previous tax years, if
- 4 the withdrawal was not a qualified withdrawal as provided in the
- 5 Michigan education savings program act, 2000 PA 161, MCL 390.1471
- 6 to 390.1486. This subdivision does not apply to withdrawals that
- 7 are less than the sum of all contributions made to an education
- 8 savings account in all previous tax years for which no deduction
- 9 was claimed under subdivision (w), less any contributions for
- 10 which no deduction was claimed under subdivision (w) that were
- 11 withdrawn in all previous tax years.
- 12 (y) For tax years that begin after December 31, 1999,
- 13 deduct, to the extent included in adjusted gross income, the
- 14 amount of a distribution from individual retirement accounts that
- 15 qualify under section 408 of the internal revenue code if the
- 16 distribution is used to pay qualified higher education expenses
- 17 as that term is defined in the Michigan education savings program
- 18 act, 2000 PA 161, MCL 390.1471 to 390.1486.
- 19 (z) For tax years that begin after December 31, 2000,
- 20 deduct, to the extent included in adjusted gross income, an
- 21 amount equal to the qualified charitable distribution made in the
- 22 tax year by a taxpayer to a charitable organization. The amount
- 23 allowed under this subdivision shall be equal to the amount
- 24 deductible by the taxpayer under section 170(c) of the internal
- 25 revenue code with respect to the qualified charitable
- 26 distribution in the tax year in which the taxpayer makes the
- 27 distribution to the qualified charitable organization, reduced by

- 1 both the amount of the deduction for retirement or pension
- 2 benefits claimed by the taxpayer under subdivision (f)(i), (ii),
- 3 (iv), or (v) and by 2 times the total amount of credits claimed
- 4 under sections 260 and 261 for the tax year. As used in this
- 5 subdivision, "qualified charitable distribution" means a
- 6 distribution of assets to a qualified charitable organization by
- 7 a taxpayer not more than 60 days after the date on which the
- 8 taxpayer received the assets as a distribution from a retirement
- 9 or pension plan described in subsection (8)(a). A distribution is
- 10 to a qualified charitable organization if the distribution is
- 11 made in any of the following circumstances:
- 12 (i) To an organization described in section 501(c)(3) of the
- 13 internal revenue code except an organization that is controlled
- 14 by a political party, an elected official or a candidate for an
- 15 elective office.
- 16 (ii) To a charitable remainder annuity trust or a charitable
- 17 remainder unitrust as defined in section 664(d) of the internal
- 18 revenue code; to a pooled income fund as defined in section
- 19 642(c)(5) of the internal revenue code; or for the issuance of a
- 20 charitable gift annuity as defined in section 501(m)(5) of the
- 21 internal revenue code. A trust, fund, or annuity described in
- 22 this subparagraph is a qualified charitable organization only if
- 23 no person holds any interest in the trust, fund, or annuity other
- 24 than 1 or more of the following:
- 25 (A) The taxpayer who received the distribution from the
- 26 retirement or pension plan.
- 27 (B) The spouse of an individual described in sub-

- 1 subparagraph (A).
- 2 (C) An organization described in section 501(c)(3) of the
- 3 internal revenue code.
- 4 (aa) A taxpayer who is a resident tribal member may deduct,
- 5 to the extent included in adjusted gross income, all nonbusiness
- 6 income earned or received in the tax year and during the period
- 7 in which an agreement entered into between the taxpayer's tribe
- 8 and this state pursuant to section 30c of 1941 PA 122, MCL
- 9 205.30c, is in full force and effect. As used in this
- 10 subdivision:
- 11 (i) "Business income" means business income as defined in
- 12 section 4 and apportioned under chapter 3.
- 13 (ii) "Nonbusiness income" means nonbusiness income as defined
- 14 in section 14 and, to the extent not included in business income,
- 15 all of the following:
- 16 (A) All income derived from wages whether the wages are
- 17 earned within the agreement area or outside of the agreement
- 18 area.
- 19 (B) All interest and passive dividends.
- 20 (C) All rents and royalties derived from real property
- 21 located within the agreement area.
- 22 (D) All rents and royalties derived from tangible personal
- 23 property, to the extent the personal property is utilized within
- 24 the agreement area.
- 25 (E) Capital gains from the sale or exchange of real property
- 26 located within the agreement area.
- 27 (F) Capital gains from the sale or exchange of tangible

- 1 personal property located within the agreement area at the time
- 2 of sale.
- 3 (G) Capital gains from the sale or exchange of intangible
- 4 personal property.
- 5 (H) All pension income and benefits including, but not
- 6 limited to, distributions from a 401(k) plan, individual
- 7 retirement accounts under section 408 of the internal revenue
- 8 code, or a defined contribution plan, or payments from a defined
- 9 benefit plan.
- 10 (I) All per capita payments by the tribe to resident tribal
- 11 members, without regard to the source of payment.
- (J) All gaming winnings.
- 13 (iii) "Resident tribal member" means an individual who meets
- 14 all of the following criteria:
- 15 (A) Is an enrolled member of a federally recognized tribe.
- 16 (B) The individual's tribe has an agreement with this state
- 17 pursuant to section 30c of 1941 PA 122, MCL 205.30c, that is in
- 18 full force and effect.
- 19 (C) The individual's principal place of residence is located
- 20 within the agreement area as designated in the agreement under
- 21 sub-subparagraph (B).
- 22 (bb) For tax years that begin after December 31, 2006,
- 23 deduct, to the extent included in adjusted gross income, all or a
- 24 portion of the gain, as determined under this section, realized
- 25 from an initial equity investment of not less than \$100,000.00
- 26 made by the taxpayer before December 31, 2009, in a qualified
- 27 business, if an amount equal to the sum of the taxpayer's basis

- 1 in the investment as determined under the internal revenue code
- 2 plus the gain, or a portion of that amount, is reinvested in an
- 3 equity investment in a qualified business within 1 year after the
- 4 sale or disposition of the investment in the qualified business.
- 5 If the amount of the subsequent investment is less than the sum
- 6 of the taxpayer's basis from the prior equity investment plus the
- 7 gain from the prior equity investment, the amount of a deduction
- 8 under this section shall be reduced by the difference between the
- 9 sum of the taxpayer's basis from the prior equity investment plus
- 10 the gain from the prior equity investment and the subsequent
- 11 investment. As used in this subdivision:
- 12 (i) "Advanced automotive, manufacturing, and materials
- 13 technology" means any technology that involves 1 or more of the
- 14 following:
- 15 (A) Materials with engineered properties created through the
- 16 development of specialized process and synthesis technology.
- 17 (B) Nanotechnology, including materials, devices, or systems
- 18 at the atomic, molecular, or macromolecular level, with a scale
- 19 measured in nanometers.
- 20 (C) Microelectromechanical systems, including devices or
- 21 systems integrating microelectronics with mechanical parts and a
- 22 scale measured in micrometers.
- 23 (D) Improvements to vehicle safety, vehicle performance,
- 24 vehicle production, or environmental impact, including, but not
- 25 limited to, vehicle equipment and component parts.
- 26 (E) Any technology that involves an alternative energy
- 27 vehicle or its components. "Alternative energy vehicle" means

- 1 that term as defined in section 2 of the Michigan next energy
- 2 authority act, 2002 PA 593, MCL 207.822.
- 3 (F) A new technology, device, or system that enhances or
- 4 improves the manufacturing process of wood, timber, or
- 5 agricultural-based products.
- 6 (G) Advanced computing or electronic device technology
- 7 related to technology described under this subparagraph.
- 8 (H) Design, engineering, testing, or diagnostics related to
- 9 technology described under this subparagraph.
- 10 (I) Product research and development related to technology
- 11 described under this subparagraph.
- 12 (ii) "Advanced computing" means any technology used in the
- 13 design and development of 1 or more of the following:
- 14 (A) Computer hardware and software.
- 15 (B) Data communications.
- 16 (C) Information technologies.
- 17 (iii) "Alternative energy technology" means applied research
- 18 or commercialization of new or next generation technology in 1 or
- 19 more of the following:
- 20 (A) Alternative energy technology as that term is defined in
- 21 section 2 of the Michigan next energy authority act, 2002 PA 593,
- 22 MCL 207.822.
- 23 (B) Devices or systems designed and used solely for the
- 24 purpose of generating energy from agricultural crops, residue and
- 25 waste generated from the production and processing of
- 26 agricultural products, animal wastes, or food processing wastes,
- 27 not including a conventional gasoline or diesel fuel engine or a

- 1 retrofitted conventional gasoline or diesel fuel engine.
- 2 (C) A new technology, product, or system that permits the
- 3 utilization of biomass for the production of specialty,
- 4 commodity, or foundational chemicals or of novel or economical
- 5 commodity materials through the application of biotechnology that
- 6 minimizes, complements, or replaces reliance on petroleum for the
- 7 production.
- 8 (D) Advanced computing or electronic device technology
- 9 related to technology described under this subparagraph.
- 10 (E) Design, engineering, testing, or diagnostics related to
- 11 technology described under this subparagraph.
- 12 (F) Product research and development related to a technology
- 13 described under this subparagraph.
- 14 (iv) "Competitive edge technology" means 1 or more of the
- 15 following:
- 16 (A) Advanced automotive, manufacturing, and materials
- 17 technology.
- 18 (B) Alternative energy technology.
- 19 (C) Homeland security and defense technology.
- 20 (D) Life sciences technology.
- 21 (v) "Electronic device technology" means any technology that
- 22 involves microelectronics, semiconductors, electronic equipment,
- 23 and instrumentation, radio frequency, microwave, and millimeter
- 24 electronics; optical and optic-electrical devices; or data and
- 25 digital communications and imaging devices.
- 26 (vi) "Homeland security and defense technology" means
- 27 technology that assists in the assessment of threats or damage to

- 1 the general population and critical infrastructure, protection
- 2 of, defense against, or mitigation of the effects of foreign or
- 3 domestic threats, disasters, or attacks, or support for crisis or
- 4 response management, including, but not limited to, 1 or more of
- 5 the following:
- 6 (A) Sensors, systems, processes, or equipment for
- 7 communications, identification and authentication, screening,
- 8 surveillance, tracking, and data analysis.
- 9 (B) Advanced computing or electronic device technology
- 10 related to technology described under this subparagraph.
- 11 (C) Aviation technology including, but not limited to,
- 12 avionics, airframe design, sensors, early warning systems, and
- 13 services related to the technology described in this
- 14 subparagraph.
- 15 (D) Design, engineering, testing, or diagnostics related to
- 16 technology described under this subparagraph.
- 17 (E) Product research and development related to technology
- 18 described under this subparagraph.
- 19 (vii) "Life sciences technology" means any technology derived
- 20 from life sciences intended to improve human health or the
- 21 overall quality of human life, including, but not limited to,
- 22 systems, processes, or equipment for drug or gene therapies,
- 23 biosensors, testing, medical devices or instrumentation with a
- 24 therapeutic or diagnostic value, a pharmaceutical or other
- 25 product that requires United States food and drug administration
- 26 approval or registration prior to its introduction in the
- 27 marketplace and is a drug or medical device as defined by the

- 1 federal food, drug, and cosmetic act, 21 USC 301 to 399, or 1 or
- 2 more of the following:
- 3 (A) Advanced computing or electronic device technology
- 4 related to technology described under this subparagraph.
- 5 (B) Design, engineering, testing, or diagnostics related to
- 6 technology or the commercial manufacturing of technology

- 7 association of churches.
- 8 (iii) All other unqualified pension plans that prescribe
- 9 eligibility for retirement and predetermine contributions and
- 10 benefits if the distributions are made from a pension trust.
- 11 (c) Retirement or pension benefits received by a surviving
- 12 spouse if those benefits qualified for a deduction prior to the
- 13 decedent's death. Benefits received by a surviving child are not
- 14 deductible.
- 15 (d) Retirement and pension benefits do not include:
- 16 (i) Amounts received from a plan that allows the employee to
- 17 set the amount of compensation to be deferred and does not
