SUBSTITUTE FOR HOUSE BILL NO. 5411

A bill to amend 1976 PA 451, entitled
"The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1312a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1312A. (1) NOT LATER THAN THE BEGINNING OF THE 2008-2009
- 2 SCHOOL YEAR, THE BOARD OF A SCHOOL DISTRICT OR INTERMEDIATE SCHOOL
- 3 DISTRICT OR BOARD OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY SHALL
- 4 ENSURE THAT ALL OF THE FOLLOWING ARE INCLUDED IN THE CODE OF
- 5 STUDENT CONDUCT UNDER SECTION 1312:
- 6 (A) A DETAILED DESCRIPTION OF THE DUE PROCESS RIGHTS THAT MUST
- 7 BE PROVIDED FOR A PUPIL OR A PUPIL'S PARENT OR LEGAL GUARDIAN IN
- 8 PERMANENT EXPULSION PROCEEDINGS.
- 9 (B) A DETAILED DESCRIPTION OF THE SCHOOL DISTRICT'S,
- 10 INTERMEDIATE SCHOOL DISTRICT'S, OR PUBLIC SCHOOL ACADEMY'S
- 11 PROCEDURES FOR A PERMANENT EXPULSION, INCLUDING THE PROCESS FOR
- 12 REINSTATEMENT UNDER SECTION 1311(5) OR 1311A(5).

- (2) IF PROCEEDINGS ARE INITIATED TO PERMANENTLY EXPEL A PUPIL, 1
- 2 THE BOARD OF THE SCHOOL DISTRICT OR INTERMEDIATE SCHOOL DISTRICT OR
- 3 BOARD OF DIRECTORS OF THE PUBLIC SCHOOL ACADEMY SHALL ENSURE THAT A
- COPY OF THE INFORMATION REQUIRED UNDER SUBSECTION (1) IS PROVIDED 4
- TO THE PUPIL AND THE PUPIL'S PARENT OR LEGAL GUARDIAN AT THE SAME 5
- TIME AS THE NOTICE OF THE CHARGES AGAINST THE PUPIL IS PROVIDED TO
- THE PUPIL AND THE PUPIL'S PARENT OR LEGAL GUARDIAN. 7
- (3) THIS SECTION DOES NOT DIMINISH ANY RIGHTS UNDER FEDERAL 8
- LAW OF A PUPIL WHO HAS BEEN DETERMINED TO BE ELIGIBLE FOR SPECIAL
- 10 EDUCATION PROGRAMS AND SERVICES.
- 11 Enacting section 1. This amendatory act does not take effect
- 12 unless House Bill No. 5832 of the 94th Legislature is enacted into
- 13 law.
