## SUBSTITUTE FOR HOUSE BILL NO. 4594

A bill to amend 1972 PA 382, entitled "Traxler-McCauley-Law-Bowman bingo act," by amending sections 2, 3, and 9 (MCL 432.102, 432.103, and 432.109), sections 2 and 9 as amended by 1999 PA 108 and section 3 as amended by 2006 PA 427.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. AS USED IN THIS ACT:
- 2 (A) "ACTIVE SERVICE" AND "ACTIVE STATE SERVICE" MEAN THOSE
- 3 TERMS AS DEFINED IN SECTION 105 OF THE MICHIGAN MILITARY ACT, 1967
- 4 PA 150, MCL 32.505.
- 5 (B) (1)—"Advertising" means all printed matter, handouts,
- 6 flyers, radio, television, advertising signs, billboards, and other
- 7 media used to promote an event licensed under this act.
- 8 (C) (2) "Bingo" means a game of chance commonly known as bingo
- 9 in which prizes are awarded on the basis of designated numbers or

- 1 symbols conforming to numbers or symbols selected at random.
- 2 (D) (3)—"Bureau" means the bureau of state lottery as created
- 3 by **SECTION 5 OF** the McCauley-Traxler-Law-Bowman-McNeely lottery
- 4 act, 1972 PA 239, MCL 432.1 to 432.47 432.5.
- 5 (E)  $\frac{(4)}{}$  "Charity game" means the random resale of a series of
- 6 charity game tickets.
- 7 (F) (5)—"Charity game ticket" means a ticket commonly referred
- 8 to as a break open BREAK-OPEN ticket or pull-tab that is approved
- 9 and acquired by the bureau and is distributed and sold by the
- 10 bureau or a licensed supplier to a qualified organization, a
- 11 portion of which is removed to discover whether the ticket is a
- 12 winning ticket and whether the purchaser may be awarded a prize.
- (G) (6) "Commissioner" means the commissioner of state lottery
- 14 as defined by section 3 APPOINTED UNDER SECTION 7 of the McCauley-
- 15 Traxler-Law-Bowman-McNeely lottery act, 1972 PA 239, MCL 432.3

- 17 (H) (7) "Coverall pattern" means a pattern required to win a
- 18 bingo game in which all numbers on a bingo card are required to be
- 19 called.
- 20 Sec. 3. AS USED IN THIS ACT:
- 21 (A) (1)—"Educational organization" means an organization
- 22 within this state that is organized not for pecuniary profit, whose
- 23 primary purpose is educational in nature and designed to develop
- 24 the capabilities of individuals by instruction in any public or
- 25 private elementary or secondary school that complies with the
- 26 revised school code, 1976 PA 451, MCL 380.1 to 380.1852, or any
- 27 private or public college or university that is organized not for

- 1 pecuniary profit and that is approved by the state board of
- 2 education.
- 3 (B) (2)—"Fraternal organization" means an organization within
- 4 this state, except a college fraternity or sorority, that is
- 5 organized not for pecuniary profit; that is a branch, lodge, or
- 6 chapter of a national or state organization; and that exists for
- 7 the common purpose, brotherhood, or other interests of its members.
- 8 (C) (3) "Licensee" means a person or qualified organization
- 9 licensed under this act.
- 10 (D) (4)—"Member" means an individual who qualified for
- 11 membership in a qualified organization under its bylaws, articles
- 12 of incorporation, charter, rules, or other written statement.
- 13 (E) "MICHIGAN NATIONAL GUARD" AND "MILITARY" MEAN THOSE TERMS
- 14 AS DEFINED IN SECTION 105 OF THE MICHIGAN MILITARY ACT, 1967 PA
- 15 150, MCL 32.505.
- (F) (5) "Person" means a natural person, firm, association,
- 17 corporation, or other legal entity.
- 18 (G) (6) "Qualified organization" means, a—SUBJECT TO
- 19 SUBDIVISION (H), EITHER OF THE FOLLOWING:
- 20 (i) A bona fide religious, educational, service, senior
- 21 citizens, fraternal, or veterans' organization that operates
- 22 without profit to its members and that either has been in existence
- 23 continuously as an organization for a period of 5 years or is
- 24 exempt from taxation under 26 USC 501(c). Qualified organization
- 25 (ii) ONLY FOR THE PURPOSE OF CONDUCTING A SMALL RAFFLE OR A
- 26 LARGE RAFFLE UNDER THIS ACT, A COMPONENT OF THE MILITARY OR THE
- 27 MICHIGAN NATIONAL GUARD WHOSE MEMBERS ARE IN ACTIVE SERVICE OR

- 2 (H) "QUALIFIED ORGANIZATION" does not include a candidate
- 3 committee, political committee, political party committee, ballot
- 4 question committee, independent committee, or any other committee
- 5 as defined by, and organized under, the Michigan campaign finance
- 6 act, 1976 PA 388, MCL 169.201 to 169.282.
- 7 (I) (7)—"Religious organization" means any of the following:
- 8 (i) (a) An organization, church, body of communicants, or group
- 9 that is organized not for pecuniary profit and that gathers in
- 10 common membership for mutual support and edification in piety,
- 11 worship, and religious observances.
- 12 (ii) (b)—A society of individuals that is organized not for
- 13 pecuniary profit and that unites for religious purposes at a
- 14 definite place.
- 15 (iii) (c)—A church related private school that is organized not
- 16 for pecuniary profit.
- 17 (J) (8) "Senior citizens organization" means an organization
- 18 within this state that is organized not for pecuniary profit, that
- 19 consists of at least 15 members who are 60 years of age or older,
- 20 and that exists for their mutual support and for the advancement of
- 21 the causes of elderly or retired persons.
- 22 (K) (9)—"Service organization" means either of the following:
- 23 (i) (a) A branch, lodge, or chapter of a national or state
- 24 organization that is organized not for pecuniary profit and that is
- 25 authorized by its written constitution, charter, articles of
- 26 incorporation, or bylaws to engage in a fraternal, civic, or
- 27 service purpose within the state.

- 2 pecuniary profit; that is not affiliated with a state or national
- 3 organization; that is recognized by resolution adopted by the local
- 4 governmental subdivision in which the organization conducts its
- 5 principal activities; whose constitution, charter, articles of
- 6 incorporation, or bylaws contain a provision for the perpetuation
- 7 of the organization as a nonprofit organization; whose entire
- 8 assets are used for charitable purposes; and whose constitution,

- 10 that all assets, real property, and personal property shall revert
- 11 to the benefit of the local governmental subdivision that granted

- 14 this state, or a branch, lodge, or chapter within this state of a
- 15 state organization or of a national organization chartered by the
- 16 congress of the United States, that is organized not for pecuniary
- 17 profit, the membership of which consists of individuals who were
- 18 members of the armed services or ARMED forces of the United States.
- 19 Sec. 9. (1) The EXCEPT AS PROVIDED IN SUBSECTION (2), THE
- 20 entire net proceeds of an event shall be devoted exclusively to the
- 21 lawful purposes of the licensee. A licensee shall not incur or pay
- 22 an item of expense in connection with the holding, operating, or
- 23 conducting of an event except the following expenses in reasonable
- 24 amounts:
- 25 (a) The purchase or rental of equipment necessary for
- 26 conducting an event and payment of services reasonably necessary
- 27 for the repair of equipment.

- 1 (b) Cash prizes or the purchase of prizes of merchandise.
- 2 (c) Rental of the location at which the event is conducted.
- 3 (d) Janitorial services.
- 4 (e) The fee required for issuance or reissuance of a license
- 5 to conduct the event.
- 6 (f) Other reasonable expenses incurred by the licensee, not
- 7 inconsistent with this act, as permitted by rule of the
- 8 commissioner.
- 9 (2) A QUALIFIED ORGANIZATION DESCRIBED IN SECTION 3 (G) (ii)
- 10 SHALL USE THE ENTIRE NET PROCEEDS OF AN EVENT, AFTER PAYING ITEMS
- 11 OF EXPENSE INCURRED IN REASONABLE AMOUNTS IN CONNECTION WITH THE
- 12 HOLDING, OPERATING, OR CONDUCTING OF THE EVENT AND LISTED IN
- 13 SUBSECTION (1), ONLY FOR THE EXPENSE OF TRAINING OR PURCHASING
- 14 GOODS OR SERVICES FOR THE SUPPORT OF THE ACTIVITIES OF THE
- 15 COMPONENT.
