

**SUBSTITUTE FOR
HOUSE BILL NO. 4863**

A bill to amend 1974 PA 93, entitled
"An act to license and regulate horse riding stables and sales
barns; to prescribe the duties of the department of agriculture;
and to provide a penalty,"
by amending section 3 (MCL 287.113), as amended by 2003 PA 86.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 3. (1) The department shall require an applicant for
2 license to furnish information it considers necessary to determine
3 that the applicant is of good reputation and character, adequately
4 financed to carry out the business that it intends to pursue, and
5 sufficiently knowledgeable in the business. The department may
6 conduct further investigation and require further information that
7 it considers necessary to establish the sufficiency of the
8 application.

1 ~~(2) Before October 1, 2003 or after September 30, 2007 and~~
2 ~~upon~~ **UPON** filing an application, the applicant shall pay a fee of
3 ~~\$25.00 for each license. Beginning October 1, 2003 through~~
4 ~~September 30, 2007, the applicant shall pay a fee of \$100.00 for~~
5 each license **UNTIL SEPTEMBER 30, 2012 AND \$25.00 FOR EACH LICENSE**
6 **AFTER SEPTEMBER 30, 2012.** ~~The revenue shall be deposited in the~~
7 ~~general fund.~~

8 (3) The license shall be displayed prominently in the
9 licensee's place of business. An applicant shall obtain a separate
10 license for each business location. Licenses are not transferable
11 and expire on the following January 1.

12 ~~(4) Before October 1, 2003 or after September 30, 2007, a~~ **A**
13 licensee may renew his or her license upon paying a renewal fee of
14 ~~\$25.00. Beginning October 1, 2003 through September 30, 2007, the~~
15 ~~renewal fee is~~ **\$50.00 UNTIL SEPTEMBER 30, 2012 AND \$25.00 AFTER**
16 **SEPTEMBER 30, 2012.** ~~The revenue shall be deposited in the general~~
17 ~~fund.~~

18 **(5) THE DEPARTMENT SHALL DEPOSIT ADMINISTRATIVE AND**
19 **NONCRIMINAL FINES RECEIVED UNDER THIS ACT AND LICENSE FEES AND**
20 **OTHER ADMINISTRATIVE FEES RECEIVED UNDER THIS SECTION IN THE**
21 **AGRICULTURE LICENSING AND INSPECTION FEES FUND CREATED IN SECTION 9**
22 **OF THE INSECT PEST AND PLANT DISEASE ACT, 1931 PA 189, MCL 286.209,**
23 **TO BE USED, PURSUANT TO APPROPRIATION, BY THE DIRECTOR IN**
24 **ADMINISTERING AND CARRYING OUT THOSE DUTIES REQUIRED BY LAW UNDER**
25 **THIS ACT.**

26 Enacting section 1. This amendatory act does not take effect
27 unless House Bill No. 4862 of the 94th Legislature is enacted into

1 law.
