## SUBSTITUTE FOR HOUSE BILL NO. 5556

A bill to amend 1937 PA 94, entitled "Use tax act,"

by amending sections 2, 2b, 3a, 3b, 3c, 4d, 4i, 7, 13, 14a, and 14b (MCL 205.92, 205.92b, 205.93a, 205.93b, 205.93c, 205.94d, 205.94i, 205.97, 205.103, 205.104a, and 205.104b), sections 2 and 7 as amended by 2007 PA 103, section 2b as amended by 2006 PA 428, section 3a as amended by 2007 PA 93, section 3b as added by 2002 PA 456, sections 3c, 13, 14a, and 14b as added and section 4d as amended by 2004 PA 172, and section 4i as added by 1986 PA 41; and to repeal acts and parts of acts.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2. As used in this act:
- 2 (a) "Person" means an individual, firm, partnership, joint

- 1 venture, association, social club, fraternal organization,
- 2 municipal or private corporation whether or not organized for
- 3 profit, company, limited liability company, estate, trust,
- 4 receiver, trustee, syndicate, the United States, this state,
- 5 county, or any other group or combination acting as a unit, and the
- 6 plural as well as the singular number, unless the intention to give
- 7 a more limited meaning is disclosed by the context.
- 8 (b) "Use" means the exercise of a right or power over tangible
- 9 personal property incident to the ownership of that property
- 10 including transfer of the property in a transaction where
- 11 possession is given. Converting tangible personal property acquired
- 12 for a use exempt from the tax levied under this act to a use not
- 13 exempt from the tax levied under this act is a taxable use.
- 14 (c) "Storage" means a keeping or retention of property in this
- 15 state for any purpose after the property loses its interstate
- 16 character.
- 17 (d) "Seller" means the person from whom a purchase is made and
- 18 includes every person selling tangible personal property or
- 19 services for storage, use, or other consumption in this state. If,
- 20 in the opinion of the department, it is necessary for the efficient
- 21 administration of this act to regard a salesperson, representative,
- 22 peddler, or canvasser as the agent of a dealer, distributor,
- 23 supervisor, or employer under whom the person operates or from whom
- 24 he or she obtains tangible personal property or services sold by
- 25 him or her for storage, use, or other consumption in this state,
- 26 irrespective of whether or not he or she is making the sales on his
- 27 or her own behalf or on behalf of the dealer, distributor,

- 1 supervisor, or employer, the department may so consider him or her,
- 2 and may consider the dealer, distributor, supervisor, or employer
- 3 as the seller for the purpose of this act.
- 4 (e) "Purchase" means to acquire for a consideration, whether
- 5 the acquisition is effected by a transfer of title, of possession,
- 6 or of both, or a license to use or consume; whether the transfer is
- 7 absolute or conditional, and by whatever means the transfer is
- 8 effected; and whether consideration is a price or rental in money,
- 9 or by way of exchange or barter. Purchase includes converting
- 10 tangible personal property acquired for a use exempt from the tax
- 11 levied under this act to a use not exempt from the tax levied under
- 12 this act.
- (f) "Purchase price" or "price" means the total amount of
- 14 consideration paid by the consumer to the seller, including cash,
- 15 credit, property, and services, for which tangible personal
- 16 property or services are sold, leased, or rented, valued in money,
- 17 whether received in money or otherwise, and applies to the measure
- 18 subject to use tax. Purchase price includes the following
- 19 subparagraphs (i) through  $\frac{(vi)}{(vii)}$  and excludes subparagraphs  $\frac{(vii)}{(vii)}$
- 20 (viii) through  $\frac{(viii)}{(x)}$ :
- 21 (i) Seller's cost of the property sold.
- 22 (ii) Cost of materials used, labor or service cost, interest,
- 23 losses, costs of transportation to the seller, taxes imposed on the
- 24 seller other than taxes imposed by this act, and any other expense
- 25 of the seller.
- 26 (iii) Charges by the seller for any services necessary to
- 27 complete the sale, other than the following:

- 1 (A) An amount received or billed by the taxpayer for
- 2 remittance to the employee as a gratuity or tip, if the gratuity or
- 3 tip is separately identified and itemized on the guest check or
- 4 billed to the customer.
- 5 (B) Labor or service charges involved in maintenance and
- 6 repair work on tangible personal property of others if separately
- 7 itemized.
- 8 (iv) Delivery charges incurred or to be incurred before the
- 9 completion of the transfer of ownership of tangible personal
- 10 property SUBJECT TO THE TAX LEVIED UNDER THIS ACT from the seller
- 11 to the purchaser.
- 12 (v) Installation charges incurred or to be incurred before the
- 13 completion of the transfer of ownership of tangible personal
- 14 property from the seller to the purchaser.
- 15 (vi) Credit for any trade-in.
- 16 (vii) EXCEPT AS OTHERWISE PROVIDED IN SUBPARAGRAPH (x),
- 17 CONSIDERATION RECEIVED BY THE SELLER FROM THIRD PARTIES IF ALL OF
- 18 THE FOLLOWING CONDITIONS ARE MET:
- 19 (A) THE SELLER ACTUALLY RECEIVES CONSIDERATION FROM A PARTY
- 20 OTHER THAN THE PURCHASER AND THE CONSIDERATION IS DIRECTLY RELATED
- 21 TO A PRICE REDUCTION OR DISCOUNT ON THE SALE.
- 22 (B) THE SELLER HAS AN OBLIGATION TO PASS THE PRICE REDUCTION
- 23 OR DISCOUNT THROUGH TO THE PURCHASER.
- 24 (C) THE AMOUNT OF THE CONSIDERATION ATTRIBUTABLE TO THE SALE
- 25 IS FIXED AND DETERMINABLE BY THE SELLER AT THE TIME OF THE SALE OF
- 26 THE ITEM TO THE PURCHASER.
- 27 (D) ONE OF THE FOLLOWING CRITERIA IS MET:

- 1 (I) THE PURCHASER PRESENTS A COUPON, CERTIFICATE, OR OTHER
- 2 DOCUMENTATION TO THE SELLER TO CLAIM A PRICE REDUCTION OR DISCOUNT
- 3 WHERE THE COUPON, CERTIFICATE, OR DOCUMENTATION IS AUTHORIZED,
- 4 DISTRIBUTED, OR GRANTED BY A THIRD PARTY WITH THE UNDERSTANDING
- 5 THAT THE THIRD PARTY WILL REIMBURSE ANY SELLER TO WHOM THE COUPON,
- 6 CERTIFICATE, OR DOCUMENTATION IS PRESENTED.
- 7 (II) THE PURCHASER IDENTIFIES HIMSELF OR HERSELF TO THE SELLER
- 8 AS A MEMBER OF A GROUP OR ORGANIZATION ENTITLED TO A PRICE
- 9 REDUCTION OR DISCOUNT. A PREFERRED CUSTOMER CARD THAT IS AVAILABLE
- 10 TO ANY PATRON DOES NOT CONSTITUTE MEMBERSHIP IN A GROUP OR
- 11 ORGANIZATION.
- 12 (III) THE PRICE REDUCTION OR DISCOUNT IS IDENTIFIED AS A THIRD
- 13 PARTY PRICE REDUCTION OR DISCOUNT ON THE INVOICE RECEIVED BY THE
- 14 PURCHASER OR ON A COUPON, CERTIFICATE, OR OTHER DOCUMENTATION
- 15 PRESENTED BY THE PURCHASER.
- 16 (viii) (viii)—Interest, financing, or carrying charges from credit
- 17 extended on the sale of personal property or services, if the
- 18 amount is separately stated on the invoice, bill of sale, or
- 19 similar document given to the purchaser.
- 20 (ix) (viii)—Any taxes legally imposed directly on the consumer
- 21 that are separately stated on the invoice, bill of sale, or similar
- 22 document given to the purchaser.
- 23 (x) BEGINNING JANUARY 1, 2000, EMPLOYEE DISCOUNTS THAT ARE
- 24 REIMBURSED BY A THIRD PARTY ON SALES OF MOTOR VEHICLES.
- 25 (q) "Consumer" means the person who has purchased tangible
- 26 personal property or services for storage, use, or other
- 27 consumption in this state and includes, but is not limited to, 1 or

- 1 more of the following:
- 2 (i) A person acquiring tangible personal property if engaged in
- 3 the business of constructing, altering, repairing, or improving the
- 4 real estate of others.
- 5 (ii) A person who has converted tangible personal property or
- 6 services acquired for storage, use, or consumption in this state
- 7 that is exempt from the tax levied under this act to storage, use,
- 8 or consumption in this state that is not exempt from the tax levied
- 9 under this act.
- 10 (h) "Business" means all activities engaged in by a person or
- 11 caused to be engaged in by a person with the object of gain,
- 12 benefit, or advantage, either direct or indirect.
- (i) "Department" means the department of treasury.
- 14 (j) "Tax" includes all taxes, interest, or penalties levied
- 15 under this act.
- 16 (k) "Tangible personal property" means personal property that
- 17 can be seen, weighed, measured, felt, or touched or that is in any
- 18 other manner perceptible to the senses and includes electricity,
- 19 water, gas, steam, and prewritten computer software.
- 20 (1) "Textiles" means goods that are made of or incorporate
- 21 woven or nonwoven fabric, including, but not limited to, clothing,
- 22 shoes, hats, gloves, handkerchiefs, curtains, towels, sheets,
- 23 pillows, pillowcases, tablecloths, napkins, aprons, linens, floor
- 24 mops, floor mats, and thread. Textiles also include materials used
- 25 to repair or construct textiles, or other goods used in the rental,
- 26 sale, or cleaning of textiles.
- 27 (m) "Interstate motor carrier" means a person who operates or

- 1 causes to be operated a qualified commercial motor vehicle on a
- 2 public road or highway in this state and at least 1 other state or
- 3 Canadian province.
- 4 (n) "Qualified commercial motor vehicle" means that term as
- 5 defined in section 1(i), (j), and (k) of the motor carrier fuel tax
- 6 act, 1980 PA 119, MCL 207.211.
- 7 (o) "Diesel fuel" means that term as defined in section 2(p)
- 8 of the motor fuel tax act, 2000 PA 403, MCL 207.1002.
- 9 (p) "Sale" means a transaction by which tangible personal
- 10 property or services are purchased or rented for storage, use, or
- 11 other consumption in this state.
- 12 (q) "Convert" means putting a service or tangible personal
- 13 property acquired for a use exempt from the tax levied under this
- 14 act at the time of acquisition to a use that is not exempt from the
- 15 tax levied under this act, whether the use is in whole or in part,
- 16 or permanent or not permanent. A motor vehicle purchased for resale
- 17 by a new vehicle dealer licensed under section 248(8)(a) of the
- 18 Michigan vehicle code, 1949 PA 300, MCL 257.248, and not titled in
- 19 the name of the dealer shall not be considered to be converted
- 20 prior to sale or lease by that dealer.
- 21 Sec. 2b. As used in this act:
- 22 (a) "Alcoholic beverage" means a beverage suitable for human
- 23 consumption that contains 1/2 of 1% or more of alcohol by volume.
- 24 (b) "Computer" means an electronic device that accepts
- 25 information in digital or similar form and manipulates it for a
- 26 result based on a sequence of instructions.
- 27 (c) "Computer software" means a set of coded instructions

- 1 designed to cause a computer or automatic data processing equipment
- 2 to perform a task.
- 3 (d) "Delivered electronically" means delivered from the seller
- 4 to the purchaser by means other than tangible storage media.
- (e) "Delivery charges" means charges by the seller for
- 6 preparation and delivery to a location designated by the purchaser
- 7 of tangible personal property or services. Delivery charges
- 8 include, but are not limited to, transportation, shipping, postage,
- 9 handling, crating, and packing. Beginning September 1, 2004,
- 10 delivery charges do not include the charges for delivery of direct
- 11 mail if the charges are separately stated on an invoice or similar
- 12 billing document given to the purchaser. IF A SHIPMENT INCLUDES
- 13 BOTH EXEMPT PROPERTY AND TAXABLE PROPERTY, THE SELLER SHALL
- 14 ALLOCATE THE DELIVERY CHARGE USING 1 OF THE FOLLOWING METHODS:
- 15 (i) MULTIPLY THE DELIVERY PRICE BY A FRACTION, THE NUMERATOR OF
- 16 WHICH IS THE TOTAL SALES PRICES OF THE TAXABLE PROPERTY AND THE
- 17 DENOMINATOR OF WHICH IS THE TOTAL SALES PRICES OF ALL PROPERTY IN
- 18 THE SHIPMENT.
- 19 (ii) MULTIPLY THE DELIVERY PRICE BY A FRACTION, THE NUMERATOR
- 20 OF WHICH IS THE TOTAL WEIGHT OF THE TAXABLE PROPERTY AND THE
- 21 DENOMINATOR OF WHICH IS THE TOTAL WEIGHT OF ALL PROPERTY IN THE
- 22 SHIPMENT.
- (f) "Dietary supplement" means any product, other than
- 24 tobacco, intended to supplement the diet that is all of the
- 25 following:
- 26 (i) Required to be labeled as a dietary supplement identifiable
- 27 by the "supplemental facts" box found on the label as required by

- 1 21 CFR 101.36.
- 2 (ii) Contains 1 or more of the following dietary ingredients:
- 3 (A) A vitamin.
- **4** (B) A mineral.
- 5 (C) An herb or other botanical.
- 6 (D) An amino acid.
- 7 (E) A dietary substance for use by humans to supplement the
- 8 diet by increasing the total dietary intake.
- 9 (F) A concentrate, metabolite, constituent, extract, or
- 10 combination of any ingredient listed in sub-subparagraphs (A)
- 11 through (E).
- 12 (iii) Intended for ingestion in tablet, capsule, powder,
- 13 softgel, gelcap, or liquid form, or if not intended for ingestion
- 14 in 1 of those forms, is not represented as conventional food or for
- 15 use as a sole item of a meal or of the diet.
- 16 (g) "Direct mail" means printed material delivered or
- 17 distributed by United States mail or other delivery service to a
- 18 mass audience or to addresses on a mailing list provided by the
- 19 purchaser or at the direction of the purchaser when the cost of the
- 20 items is not billed directly to the recipients, including tangible
- 21 personal property supplied directly or indirectly by the purchaser
- 22 to the direct mail seller for inclusion in the package containing
- 23 the printed material but not including multiple items of printed
- 24 material delivered to a single address.
- (h) "Drug" means a compound, substance, or preparation, or any
- 26 component of a compound, substance, or preparation, other than food
- 27 or food ingredients, dietary supplements, or alcoholic beverages,

- 1 intended for human use that is 1 or more of the following:
- 2 (i) Recognized in the official United States pharmacopoeia,
- 3 official homeopathic pharmacopoeia of the United States, or
- 4 official national formulary, or in any of their supplements.
- 5 (ii) Intended for use in the diagnosis, cure, mitigation,
- 6 treatment, or prevention of disease.
- 7 (iii) Intended to affect the structure or any function of the
- 8 body.
- 9 (i) "Durable medical equipment" means equipment for home use,
- 10 other than mobility enhancing equipment, dispensed pursuant to a
- 11 prescription, including DURABLE MEDICAL EQUIPMENT repair or
- 12 replacement parts, for that equipment, that does all of the
- 13 following:
- 14 (i) Can withstand repeated use.
- 15 (ii) Is primarily and customarily used to serve a medical
- 16 purpose.
- 17 (iii) Is not useful generally to a person in the absence of
- 18 illness or injury.
- 19 (iv) Is not worn in or on the body.
- 20 (J) "DURABLE MEDICAL EQUIPMENT REPAIR OR REPLACEMENT PARTS"
- 21 INCLUDES ALL COMPONENTS OR ATTACHMENTS USED IN CONJUNCTION WITH
- 22 DURABLE MEDICAL EQUIPMENT.
- 23 (K) <del>(j)</del> "Electronic" means relating to technology having
- 24 electrical, digital, magnetic, wireless, optical, electromagnetic,
- 25 or similar capabilities.
- 26 (l) (k)—"Lease or rental" means any transfer of possession or
- 27 control of tangible personal property for a fixed or indeterminate

- 1 term for consideration and may include future options to purchase
- 2 or extend. This definition applies only to leases and rentals
- 3 entered into after September 1, 2004 and has no retroactive impact
- 4 on leases and rentals that existed on that date. Lease or rental
- 5 does not include the following SUBPARAGRAPHS (i) THROUGH (iii) AND
- 6 INCLUDES SUBPARAGRAPH (iv):
- 7 (i) A transfer of possession or control of tangible personal
- 8 property under a security agreement or deferred payment plan that
- 9 requires the transfer of title upon completion of the required
- 10 payments.
- 11 (ii) A transfer of possession or control of tangible personal
- 12 property under an agreement requiring transfer of title upon
- 13 completion of the required payments and payment of an option price
- 14 that does not exceed \$100.00 or 1% of the total required payments,
- 15 whichever is greater.
- 16 (iii) The provision of tangible personal property along with an
- 17 operator for a fixed or indeterminate period of time, where that
- 18 operator is necessary for the equipment to perform as designed. To
- 19 be necessary, an operator must do more than maintain, inspect, or
- 20 set up the tangible personal property.
- (iv) An agreement covering motor vehicles or trailers if the
- 22 amount of consideration may be increased or decreased by reference
- 23 to the amount realized upon sale or disposition of the property as
- 24 defined in 26 USC 7701(h)(1).
- 25 (M) (l) "Mobility enhancing equipment" means equipment, other
- 26 than durable medical equipment or a motor vehicle or equipment on a
- 27 motor vehicle normally provided by a motor vehicle manufacturer,

- 1 dispensed pursuant to a prescription, including repair or
- 2 replacement parts for that equipment, that is all of the following:

- 3 (i) Primarily and customarily used to provide or increase the
- 4 ability to move from 1 place to another and is appropriate for use
- 5 at home or on a motor vehicle.
- 6 (ii) Not generally used by a person with normal mobility.
- 7 (N) (m)—"Prescription" means an order, formula, or recipe,
- 8 issued in any form of oral, written, electronic, or other means of
- 9 transmission by a licensed physician or other health professional
- 10 as defined in section 3501 of the insurance code of 1956, 1956 PA
- 11 218, MCL 500.3501. FOR A HEARING AID, PRESCRIPTION INCLUDES AN
- 12 ORDER, INSTRUCTION, OR DIRECTION OF A HEARING AID DEALER OR
- 13 SALESPERSON LICENSED UNDER ARTICLE 13 OF THE OCCUPATIONAL CODE,
- 14 1980 PA 299, MCL 339.1301 TO 339.1309.
- 15 (O) (n) "Prewritten computer software" means computer
- 16 software, including prewritten upgrades, that is delivered by any
- 17 means and that is not designed and developed by the author or other
- 18 creator to the specifications of a specific purchaser. Prewritten
- 19 computer software includes all of the following:
- 20 (i) Any combination of 2 or more prewritten computer software
- 21 programs or portions of prewritten computer software programs.
- 22 (ii) Computer software designed and developed by the author or
- 23 other creator to the specifications of a specific purchaser if it
- 24 is sold to a person other than that specific purchaser.
- 25 (iii) The modification or enhancement of prewritten computer
- 26 software or portions of prewritten computer software where the
- 27 modification or enhancement is designed and developed to the

- 1 specifications of a specific purchaser unless there is a
- 2 reasonable, separately stated charge or an invoice or other
- 3 statement of the price is given to the purchaser for the
- 4 modification or enhancement. If a person other than the original
- 5 author or creator modifies or enhances prewritten computer
- 6 software, that person is considered to be the author or creator of
- 7 only that person's modifications or enhancements.
- 8 (P) (o) "Prosthetic device" means a replacement, corrective,
- 9 or supportive device, other than contact lenses and dental
- 10 prosthesis, dispensed pursuant to a prescription, including repair
- 11 or replacement parts for that device, worn on or in the body to do
- 12 1 or more of the following:
- (i) Artificially replace a missing portion of the body.
- 14 (ii) Prevent or correct a physical deformity or malfunction of
- 15 the body.
- 16 (iii) Support a weak or deformed portion of the body.
- 17 (Q) (p) "Tobacco" means cigarettes, cigars, chewing or pipe
- 18 tobacco, or any other item that contains tobacco.
- 19 Sec. 3a. (1) The use or consumption of the following services
- 20 is taxed under this act in the same manner as tangible personal
- 21 property is taxed under this act:
- 22 (a) Except as provided in section 3b, intrastate telephone,
- 23 telegraph, leased wire, and other similar communications, including
- 24 local telephone exchange and long distance telephone service
- 25 TELECOMMUNICATIONS SERVICES that both originates and terminates
- 26 ORIGINATE AND TERMINATE in this state, and telegraph, private line,
- 27 and teletypewriter service between places in this state, but

- 1 excluding telephone service by coin-operated installations,
- 2 switchboards, concentrator-identifiers, interoffice circuitry and
- 3 their accessories for telephone answering service, INCLUDING, BUT
- 4 NOT LIMITED TO, INTRASTATE PRIVATE COMMUNICATIONS SERVICES,
- 5 ANCILLARY SERVICES, CONFERENCE BRIDGING SERVICE, 900 SERVICE, PAY
- 6 TELEPHONE SERVICE OTHER THAN COIN-OPERATED TELEPHONE SERVICE, AND
- 7 VALUE-ADDED NONVOICE DATA SERVICE, BUT EXCLUDING 800 SERVICE, COIN-
- 8 OPERATED TELEPHONE SERVICE, FIXED WIRELESS SERVICE, 1-WAY PAGING
- 9 SERVICE, PREPAID CALLING SERVICE, TELECOMMUNICATIONS NONRECURRING
- 10 CHARGES, and directory advertising proceeds.
- 11 (b) Rooms or lodging furnished by hotelkeepers, motel
- 12 operators, and other persons furnishing accommodations that are
- 13 available to the public on the basis of a commercial and business
- 14 enterprise, irrespective of whether or not membership is required
- 15 for use of the accommodations, except rooms and lodging rented for
- 16 a continuous period of more than 1 month. As used in this act,
- 17 "hotel" or "motel" means a building or group of buildings in which
- 18 the public may obtain accommodations for a consideration,
- 19 including, without limitation, such establishments as inns, motels,
- 20 tourist homes, tourist houses or courts, lodging houses, rooming
- 21 houses, nudist camps, apartment hotels, resort lodges and cabins,
- 22 camps operated by other than nonprofit organizations but not
- 23 including those licensed under 1973 PA 116, MCL 722.111 to 722.128,
- 24 and any other building or group of buildings in which
- 25 accommodations are available to the public, except accommodations
- 26 rented for a continuous period of more than 1 month and
- 27 accommodations furnished by hospitals or nursing homes.

- 1 (c) Except as provided in section 3b, interstate telephone
- 2 communications TELECOMMUNICATIONS SERVICES that either originate or
- 3 terminate in this state and for which the charge for the service is
- 4 billed to a service address in this state or phone number by the
- 5 provider either within or outside this state including, calls
- 6 between this state and any place within or without the United
- 7 States of America outside of this state. This subdivision does not
- 8 apply to a wide area telecommunication service or a similar type
- 9 service, an 800 prefix service or similar type service, an
- 10 interstate private network and related usage charges, or an
- 11 international call either inbound or outbound. BUT NOT LIMITED TO,
- 12 ANCILLARY SERVICES, CONFERENCE BRIDGING SERVICE, 900 SERVICE, PAY
- 13 TELEPHONE SERVICE OTHER THAN COIN-OPERATED TELEPHONE SERVICE, AND
- 14 VALUE-ADDED NONVOICE DATA SERVICES, BUT EXCLUDING INTERSTATE
- 15 PRIVATE COMMUNICATIONS SERVICE, 800 SERVICE, COIN-OPERATED
- 16 TELEPHONE SERVICE, FIXED WIRELESS SERVICE, 1-WAY PAGING SERVICE,
- 17 PREPAID CALLING SERVICE, TELECOMMUNICATIONS NONRECURRING CHARGES,
- 18 AND INTERNATIONAL TELECOMMUNICATIONS SERVICE.
- 19 (d) The laundering or cleaning of textiles under a sale,
- 20 rental, or service agreement with a term of at least 5 days. This
- 21 subdivision does not apply to the laundering or cleaning of
- 22 textiles used by a restaurant or retail sales business. As used in
- 23 this subdivision, "restaurant" means a food service establishment
- 24 defined and licensed under the food law of 2000, 2000 PA 92, MCL
- 25 289.1101 to 289.8111.
- (e) The transmission and distribution of electricity, whether
- 27 the electricity is purchased from the delivering utility or from

- 1 another provider, if the sale is made to the consumer or user of
- 2 the electricity for consumption or use rather than for resale.
- 3 (f) For a manufacturer who affixes its product to real estate
- 4 and maintains an inventory of its product that is available for

- 16 refund under this subdivision shall not exceed a period of 4 years.

- 19 home service provider shall provide a written explanation of that
- 20 determination to the customer. The procedures prescribed in this
- 21 subdivision and in subdivision (d) are the first course of remedy

- 18 (4) If charges for mobile telecommunications WIRELESS services
- 19 and other billed services not subject to the tax levied under this
- 20 act are aggregated with and not separately stated from charges for

- 4 (x) DIGITAL PRODUCTS DELIVERED ELECTRONICALLY, INCLUDING, BUT
- 5 NOT LIMITED TO, SOFTWARE, MUSIC, VIDEO, READING MATERIALS, OR RING
- 6 TONES.
- 7 Sec. 4d. (1) The following are exempt from the tax under this
- 8 act:
- 9 (a) Sales of drugs for human use that can only be legally
- 10 dispensed by prescription or food or food ingredients, except
- 11 prepared food intended for immediate human consumption.
- 12 (b) The deposit on a returnable container for a beverage or
- 13 the deposit on a carton or case that is used for returnable
- 14 containers.
- 15 (c) Food or tangible personal property purchased under the

- 1 (2) Food or drink heated or cooled mechanically, electrically,
- 2 or by other artificial means to an average temperature above 75

- 5 a sealed container, and fresh fruit, is subject to the tax under

- 17 ERRONEOUS CLASSIFICATION IN THE TAXABILITY MATRIX OF TERMS INCLUDED
- 18 IN THE STREAMLINED SALES AND USE TAX AGREEMENT'S LIBRARY OF
- 19 DEFINITIONS AS TAXABLE OR EXEMPT, INCLUDED IN SALES PRICE, EXCLUDED
- 20 FROM SALES PRICE, OR EXCLUDED FROM THE DEFINITION.
- 21 (5) AS USED IN THIS SECTION:
- 22 (A) "PENALTY" MEANS AN AMOUNT IMPOSED FOR NONCOMPLIANCE THAT

- 2 Sec. 13. (1) A purchaser of direct mail other than a holder of

- 14 EXEMPTION FORM IS ACTUALLY RECEIVED BY THE PURCHASER AT A LOCATION
- 15 OPERATED BY THE SELLER.
- 16 (ii) THE STATE IN WHICH THE LOCATION OPERATED BY THE SELLER IS
- 17 LOCATED PROVIDES AN EXEMPTION FORM THAT CLEARLY AND AFFIRMATIVELY
- 18 INDICATES THAT THE CLAIMED EXEMPTION IS NOT AVAILABLE IN THAT
- 19 STATE.
- 20 (6) A SELLER WHO OBTAINS A FULLY COMPLETED EXEMPTION FORM OR
- 21 CAPTURES THE RELEVANT DATA ELEMENTS AS OUTLINED IN THIS SECTION
- 22 WITHIN 120 DAYS AFTER THE DATE OF SALE IS NOT LIABLE FOR THE TAX
- 23 UNDER THIS ACT.
- 24 (7) IF THE SELLER HAS NOT OBTAINED AN EXEMPTION FORM OR ALL
- 25 RELEVANT DATA ELEMENTS, THE SELLER MAY EITHER PROVE THAT THE
- 26 TRANSACTION WAS NOT SUBJECT TO THE TAX UNDER THIS ACT BY OTHER
- 27 MEANS OR OBTAIN A FULLY COMPLETED EXEMPTION FORM FROM THE

- 1 PURCHASER, BY THE LATER OF THE FOLLOWING:
- 2 (A) 120 DAYS AFTER A REQUEST BY THE DEPARTMENT.
- 3 (B) THE DATE AN ASSESSMENT BECOMES FINAL.
- 4 (C) THE DENIAL OF A CLAIM FOR REFUND.
- 5 (D) IN THE INSTANCE OF A CREDIT AUDIT, THE ISSUANCE OF AN
- 6 AUDIT DETERMINATION LETTER OR INFORMAL CONFERENCE DECISION AND
- 7 ORDER OF DETERMINATION.
- 8 (E) THE DATE OF A FINAL ORDER OF THE COURT OF CLAIMS OR THE
- 9 MICHIGAN TAX TRIBUNAL, AS APPLICABLE, WITH RESPECT TO AN
- 10 ASSESSMENT, ORDER, OR DECISION OF THE DEPARTMENT.
- 11 (8) THE DEPARTMENT MAY, IN ITS DISCRETION, ALLOW A SELLER
- 12 ADDITIONAL TIME TO COMPLY WITH SUBSECTION (7).
- 13 (9) A SELLER IS NOT LIABLE FOR THE TAX UNDER THIS ACT IF THE
- 14 SELLER OBTAINS A BLANKET EXEMPTION FORM FOR A PURCHASER WITH WHICH
- 15 THE SELLER HAS A RECURRING BUSINESS RELATIONSHIP. RENEWALS OF
- 16 BLANKET EXEMPTION FORMS OR UPDATES OF EXEMPTION FORM INFORMATION OR
- 17 DATA ELEMENTS ARE NOT REQUIRED IF THERE IS A RECURRING BUSINESS
- 18 RELATIONSHIP BETWEEN THE SELLER AND THE PURCHASER. FOR PURPOSES OF
- 19 THIS SECTION, A RECURRING BUSINESS RELATIONSHIP EXISTS WHEN A
- 20 PERIOD OF NOT MORE THAN 12 MONTHS ELAPSES BETWEEN SALES
- 21 TRANSACTIONS.
- 22 Enacting section 1. Sections 12 and 14 of the use tax act,
- 23 1937 PA 94, MCL 205.102 and 205.104, are repealed.
