SUBSTITUTE FOR HOUSE BILL NO. 5675

A bill to amend 1956 PA 218, entitled "The insurance code of 1956,"

(MCL 500.100 to 500.8302) by adding section 404a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 404A. (1) IF A DOMESTIC, FOREIGN, OR ALIEN INSURER IS
- 2 REQUIRED BY THE COMMISSIONER DURING THE COURSE OF APPLICATION FOR
- 3 ADMISSION TO FURNISH FINANCIAL STATEMENTS OF THE APPLICANT
- 4 INSURER'S PARENT CORPORATION, WHICH CORPORATION IS A FAMILY TRUST
- 5 OR CLOSELY HELD CORPORATION WITH THE SOLE SPECIFIC PURPOSE OF
- 6 HOLDING THE ASSETS OF THE FAMILY'S PERSONAL WEALTH, OR TO FURNISH
- 7 PERSONAL FINANCIAL STATEMENTS OF CONTROLLING INDIVIDUALS OF THE
- 8 APPLICANT INSURER, ALL OF THE FOLLOWING APPLY:
- 9 (A) THE COMMISSIONER SHALL WITHHOLD THE FINANCIAL STATEMENTS
- 10 FROM PUBLIC INSPECTION.

- 1 (B) THE FINANCIAL STATEMENTS ARE TO BE HELD CONFIDENTIAL.
- 2 (C) THE FINANCIAL STATEMENTS SHALL NOT BE SUBJECT TO SUBPOENA.
- 3 (D) THE FINANCIAL STATEMENTS SHALL NOT BE DIVULGED TO ANY
- 4 PERSON, EXCEPT AS PROVIDED IN THIS SECTION.
- 5 (2) IF ASSURANCES ARE PROVIDED THAT THE FINANCIAL STATEMENTS
- 6 UNDER SUBSECTION (1) WILL BE KEPT CONFIDENTIAL, THE COMMISSIONER
- 7 MAY DISCLOSE THE FINANCIAL STATEMENTS FOR GOOD CAUSE AS FOLLOWS:
- 8 (A) TO THE GOVERNOR OR THE ATTORNEY GENERAL.
- 9 (B) TO ANY RELEVANT REGULATORY AGENCY AS IT RELATES TO THE
- 10 INSURER, INCLUDING REGULATORY AGENCIES OF OTHER STATES OR THE
- 11 FEDERAL GOVERNMENT.
- 12 (C) IN CONNECTION WITH AN ENFORCEMENT ACTION BROUGHT PURSUANT
- 13 TO THIS OR ANOTHER APPLICABLE ACT.
- 14 (D) TO LAW ENFORCEMENT OFFICIALS.
- 15 (E) TO PERSONS AUTHORIZED BY THE INGHAM COUNTY CIRCUIT COURT
- 16 TO RECEIVE THE INFORMATION.
- 17 (F) TO PERSONS ENTITLED TO RECEIVE SUCH INFORMATION IN ORDER
- 18 TO DISCHARGE DUTIES SPECIFICALLY PROVIDED FOR IN THIS ACT.
- 19 (3) THE CONFIDENTIALITY REQUIREMENTS OF SUBSECTION (1) DO NOT
- 20 APPLY IN ANY PROCEEDING OR ACTION BROUGHT AGAINST OR BY THE INSURER
- 21 UNDER THIS ACT OR ANY OTHER APPLICABLE ACT OF THIS STATE, ANY OTHER
- 22 STATE, OR THE UNITED STATES.
