

SUBSTITUTE FOR
HOUSE BILL NO. 5910

A bill to amend 1975 PA 238, entitled
"Child protection law,"
by amending section 7j (MCL 722.627j), as amended by 2004 PA 563.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 7j. (1) Upon written request, the department may provide
2 to an individual, **OR WHOEVER IS APPROPRIATE**, documentation stating
3 that the individual is not named in a central registry case as the
4 perpetrator of child abuse or child neglect. ~~The written request~~
5 ~~required under this section shall include the individual's~~
6 ~~affirmation that he or she is employed by, volunteers at, is~~
7 ~~applying for employment in, or is seeking to volunteer in a child~~
8 ~~care center, child caring institution, or child placing agency.~~

9 (2) ~~For the purpose of applying for employment or seeking to~~
10 ~~volunteer in a child care center, child caring institution, or~~

8 (3) **AN EMPLOYER, A PERSON OR AGENCY TO WHOM AN INDIVIDUAL IS**
9 **APPLYING FOR EMPLOYMENT, OR A VOLUNTEER AGENCY, WITH APPROPRIATE**
10 **AUTHORIZATION AND IDENTIFICATION FROM THE INDIVIDUAL, MAY REQUEST**
11 **AND RECEIVE CENTRAL REGISTRY CLEARANCE INFORMATION.**

12 (4) ~~(3)~~ ~~The family independence agency~~ **DEPARTMENT** may develop
13 an automated system that will allow an individual applying for
14 child-related employment or seeking to volunteer in a capacity that
15 would allow unsupervised access to a child for whom the individual
16 is not a person responsible for that child's health or welfare to
17 be listed in that system if a screening of the individual finds
18 that he or she has not been named in a central registry case as the
19 perpetrator of child abuse or child neglect. The automated system
20 developed under this section shall provide for public access to the
21 list of individuals who have been screened for the purposes of
22 complying with this section. An automated system developed under
23 this section shall have appropriate safeguards and procedures to
24 ensure that information that is confidential under this act, state
25 law, or federal law is not accessible or disclosed through that
26 system.

27 (5) ~~(4)~~ As used in this section, "child care center", "child

1 caring institution", and "child placing agency" mean those terms as
2 defined in section 1 of 1973 PA 116, MCL 722.111.
