SUBSTITUTE FOR HOUSE BILL NO. 6007

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

by amending section 50b (MCL 750.50b), as amended by 1996 PA 80.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 50b. (1) As used in this section, "animal" means any
- vertebrate other than a human being.
- 3 (2) A-EXCEPT AS OTHERWISE PROVIDED IN THIS SECTION, A person
- 4 who willfully, maliciously and without just cause or excuse kills,
- 5 tortures, mutilates, maims, or disfigures SHALL NOT DO ANY OF THE
- 6 FOLLOWING WITHOUT JUST CAUSE:
- 7 (A) KNOWINGLY KILL, TORTURE, MUTILATE, MAIM, OR DISFIGURE an
- 8 animal. or who willfully and maliciously and without just cause or
- 9 excuse administers

- 1 (B) COMMIT A RECKLESS ACT KNOWING OR HAVING REASON TO KNOW
- 2 THAT THE ACT WILL CAUSE AN ANIMAL TO BE KILLED, TORTURED,
- 3 MUTILATED, MAIMED, OR DISFIGURED.
- 4 (C) KNOWINGLY ADMINISTER poison to an animal, or exposes
- 5 KNOWINGLY EXPOSE an animal to any poisonous substance, other than a
- 6 substance that is used for therapeutic veterinary medical purposes
- 7 —with the intent that the substance be taken or swallowed by the
- 8 animal. $\overline{}$
- 9 (3) A PERSON WHO VIOLATES SUBSECTION (2) is guilty of a felony
- 10 __punishable by imprisonment 1 OR MORE OF THE FOLLOWING:
- 11 (A) IMPRISONMENT for not more than 4 years. 7 or by a
- 12 (B) A fine of not more than \$5,000.00 , or community FOR A
- 13 SINGLE ANIMAL AND \$2,500.00 FOR EACH ADDITIONAL ANIMAL INVOLVED IN
- 14 THE VIOLATION, BUT NOT TO EXCEED A TOTAL OF \$20,000.00.
- 15 (C) COMMUNITY service for not more than 500 hours. or any
- 16 combination of these penalties.
- 17 (4) (3) As a part of the sentence for a violation of
- 18 subsection (2), the court may order the defendant to pay the costs
- 19 of the prosecution and the costs of the care, housing, and
- 20 veterinary medical care for the impacted animal victim, as
- 21 applicable. If the court does not order a defendant to pay all of
- 22 the applicable costs listed in this subsection, or orders only
- 23 partial payment of these costs, the court shall state on the record
- 24 the reasons for that action.
- 25 (5) (4) If a term of probation is ordered AS PART OF THE

- 15 guilty of criminal contempt, may be punished by imprisonment for
- 16 not more than 90 days , or by a fine of not more than \$500.00, or
